REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, Narsinghdas Memorial Education Society, Plot no. 1288, Street/Road: H.O.-D.B. Vallabhdas' Palace, Vill.: Jabalpur, P.O.: Hanuman Tal, Teh./Tal.: Jabalpur, Town/City: Jabalpur, Dist: Jabalpur - 482002, Madhya Pradesh (WRCAPP2562) had submitted the application on 19.05.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission to Narmada Shiksha Mahavidyalaya, JDA Scheme no. 5, Near Survey of India Quarter, Vill.: Vijay Nagar, P.O.: Vijay Nagar, Teh./Tal.: Jabalpur, Town/City: Jabalpur, Dist: Jabalpur- 482002, Madhya Pradesh for B.A.B.Ed. 4 years integrated course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 10.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 235th meeting held on November 23-24, 2015 and the Committee decided that "....On examination of the documents, it is found that:-

- (i) Originally certified copy of the land documents is not submitted;
- (ii) Notarized copies of CLU, approved building plan, building completion certificate are not submitted; and
- (iii) Non-encumbrance certificate issued by the competent authority is not submitted.

Hence, Show Cause Notice be issued on the above grounds. The institution is also directed to clarify for which course it has applied, i.e. for B.A. B.Ed. or B.Sc. B.Ed.

State Government has not recommended the case on the ground that the institution is not a composite one. The application is for B.A. B.Ed./B.Sc. B.Ed., which in itself is composite/integrated in nature. Further, it is seen that the institution runs the B.Ed. course. Therefore, the WRC decided to process the case."

AND WHEREAS, the Show Cause Notice was issued on 02.12.2015.

AND WHEREAS, the reply dt. 16.12.2015 & 06.01.2016 of the Institution were placed before WRC in its 243rd meeting held on February 18-20, 2016. The Committee decided that "....The case file was seen. Show Cause Notice dt. 02/12/2015 was issued. The applicant has submitted the documents, as required. Hence, VT be constituted for one unit of B.A.B.Ed. course."

AND WHEREAS, the Visiting Team visited the institution on 28.02.2016.

AND WHEREAS, the visiting team report alongwith other documents were placed before WRC in its 246th meeting held on March 16-18, 2016. The Committee decided that "....The case file was seen. The VT visited the institution on 28/02/2016.

The Committee could not view the CD as it did not open. The institution be asked to send another CD."

AND WHEREAS, the Letter for obtaining another CD was issued on 24.03.2016.

AND WHEREAS, the reply dt. 13.04.2016 submitted by institution was placed before WRC in its 251st meeting held from April 30- May 02, 2016. The Committee decided that "....The VT visited the institution on 28/02/2016 but the Committee could not view the CD as it did not open. Now the institution has submitted a new CD. The VT report was perused and the CD viewed. The CD shows a building with adequate infrastructural and instructional facilities.

VT has mentioned that the built up area is only 2657 sq. mtrs which is not sufficient to run one unit of the B.A.B.Ed. course (APP2562), one unit of the D.El.Ed. course (APP2561) and the proposed shifting of the B.Ed. course (223517). The requirement for two units of the existing B.Ed. course, one unit of the B.A.B.Ed. and one unit of the D.El.Ed course is 3500 sq. mtrs. **Hence, Show Cause Notice be issued on the above ground."**

AND WHEREAS, the Show Cause Notice was issued on 05.05.2016

AND WHEREAS, the reply submitted by Institution was placed before WRC in its **261st meeting held on October 26-28, 2016**. The Committee decided that "...Consequent to the VT, a Show Cause Notice was issued to the institution on 17/05/2016 on the ground of inadequate built up area for 2 units of B.Ed.(proposed shifting), 1 unit of B.A.B.Ed. and 1 unit of D.El.Ed.

The institution has replied saying that they are not shifting the B.Ed. course to this new campus at Vijay Nagar. They will be running only 1 unit of B.A.B.Ed. and 1 unit of D.El.Ed. courses for which they have the required 2500 sq. mtrs. of built up area.

Hence, LOI be issued for one unit of the B.A.B.Ed. course."

AND WHEREAS, the LOI was issued on 04.11.2016.

AND WHEREAS, the reply dt. 26.12.2016 of LOI submitted by institution was placed before WRC in its **267th meeting held from January 23-25, 2017**. The Committee decided that "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal and 10 faculty members who are qualified as per NCTE norms but the list is not approved by the affiliating body.

Further, on examination of the files relating to D.El.Ed. course (APP2561) and the B.Ed. course (223517) show mutis mutandis, that the names are identical in all the three courses.

Hence, Show Cause Notice be issued on the above grounds. Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued on 31.01.2017.

AND WHEREAS, the reply dt. 23.02.2017 submitted by institution of Show Cause Notice was placed before WRC in its **270th meeting held on March 01-03, 2017**. The Committee decided that "...Consequent to the issue of LOI, Show Cause Notice was issued to the institution on the ground that the staff are almost identical for the D.El.Ed., B.Ed. and B.A.B.Ed. courses.

The institution has replied saying that the B.Ed. course will run in the morning shift and the B.A.B.Ed. course will run in the afternoon shift. This is not acceptable because both the courses are full time and regular.

The attention of the institution is drawn to the Appendix-4 Clause 2.2(b), NCTE Regulations, 2014. Therefore, if the same staff is working for morning and afternoon shifts, they would be engaged for at least 12 hours of duty every day which cannot be permitted. **Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition/permission to **Narmada Shiksha Mahavidyalaya, JDA Scheme no. 5, Near Survey of India Quarter, Vill.: Vijay Nagar, P.O.: Vijay Nagar, Teh./Tal.: Jabalpur, Town/City: Jabalpur, Dist: Jabalpur- 482002, Madhya Pradesh** for the B.A.B.Ed. 4 -Years integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
