REFUSAL ORDER

Date: 8 Nov 17

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, Goa Vidyaprasarak Mandal, No-276/o, street/Road- Farmagudi, Village/Town/City-Ponda, District-North Goa, State Goa-403401 (WRCAPP2596) had submitted the application on 23.06.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission to GVMS Dr. Dada Vaidya College of Education, Plot No. 276/o, street/Road-Farmagudi, Village-Bandora, Post Office-Ponda, District-North Goa, State-Goa-403401 for M.Ed. 2 years course.

AND WHEREAS, the matter was placed before the WRC in its 235th meeting held on November 23-24, 2015. The committee observed that:- "...On examination of the documents, it is found that:-

- (i) NOC from the affiliating body is not submitted.
- (ii) Originally certified copy of the land documents is not submitted.
- (iii) Notarized copy of approved building plan is not submitted.
- (iv) Building completion certificate is not submitted.

Hence, Show Cause Notice be issued on the above grounds.

AND, WHEREAS, the Show Cause Notice was issued on 02.12.2015. on the above grounds.

AND WHEREAS, the reply dt. 15.12.2015 of the Institution was placed before WRC in its 240th Meeting held on January 20-22, 2016. Committee decided that "...The case file was seen. Show Cause Notice dt. 02/12/2015 was issued on the grounds of non-submission of- NOC from affiliating body, originally certified copy of the land documents, notarized copy of Building Plan and Building Completion Certificate. Now the institution has submitted all the documents except the Building Completion Certificate, which is not originally notarized.

Hence, VT be constituted. The VT should obtain originally notarized Building Completion Certificate."

AND WHEREAS, the Visiting Team visited the institution on 05.02.2016.

AND WHEREAS, the visiting team report alongwith other documents, were placed before WRC in its 242nd Meeting held on February 11-13, 2016. The Committee decided that "...The case file was seen. The institute has applied for the M.Ed. course and it is running the B.Ed. course. The Visiting Team visited the institution on 5-6 February, 2016. The CD was viewed and VT report perused. The CD shows a good building with good infrastructural and instructional facilities as per the NCTE Norms, 2014.

Hence, LOI be issued. The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 3rd March, 2016, can the case be considered for the session 2016-2017."

AND WHEREAS, the LOI was issued on 23.02.2016. Reply submitted by institution on 01.03.2016 & 03.03.2016.

AND WHEREAS, the reply of LOI submitted by institution was placed before WRC in its 255th meeting held on June 22-24, 2016. The Committee (on 1st day) decided that:- The case file was seen. LOI dt. 23/02/2016 was issued. The replies from the applicant dt. 25/02/2016 and 29/02/2016 were examined. An examination of these two letters shows that the applicant has neither completed the formalities as required after issue of LOI, nor has it appointed the staff as required vide Appendix-5 of the NCTE Regulations, 2014.
Hence, Show Cause Notice be issued on these grounds."

AND, WHEREAS, the Show Cause Notice issued on 13.07.2016. The reply received from the institution on 02.08.2016.

AND, WHEREAS, the reply of the Institution was placed before WRC in its 261st meeting held on October 26-28, 2016. The Committee decided that "...The case file was seen. Show Cause Notice was issued to the institution on 13/07/2016. The institution vide reply 28/07/2016 has requested for an annual intake of only 20 students for the M.Ed. program with staff on Pro-rata basis. Since, this is beyond the purview of the WRC, the matter be referred to the NCTE Hqrs. enclosing the letter of the institution."

AND, WHEREAS, the Letter sent to NCTE Hqrs. on 28.12.2016. The NCTE Hqrs. Letter received on 16.01.2017.

AND, WHEREAS, the matter was placed before WRC in its 275th meeting held on May 1-2, 2017. The Committee decided that "...The case file was seen. In the 261st meeting of the WRC, the question of appointing lecturers on pro-rata basis was referred to the NCTE Hqrs. However, the NCTE Hqrs. vide letter dr. 10.01.2017 has communicated that such provision does not exist. This was communicated to the institution vide WRO letter dt. 01.03.2017. The institution replied on 13.04.2017 but it has not enclosed the list of staff appointed for the proposed M.Ed. course as per Regulations, 2014. **Show Cause Notice be issued for compliance of the norms.**"

AND, WHEREAS, the Show Cause Notice issued on 16.05.2017. The reply received from the institution on 15.06.2017.

AND, WHEREAS, the reply of the Institution was placed before WRC in its 282th meeting held on October 24-26, 2017. The Committee decided that "...The case file was seen. Show Cause Notice was issued to the institution on 16.05.2017. The institution replied on 15.06.2017. The request of the institution for an annual intake of only 20 students for the M.Ed. programme with staff on pro-rata basis was also referred to NCTE Hqrs which has refused to accept the request for reducing the intake from 50 to 20 with proportionate staff. Numerous opportunities were provided to the institution to submit the prescribed list of staff approved by the University. Since the institution has not been able to submit the faculty list as required under Appendix-V of the NCTE Regulations, 2014, **Recognition is refused.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition of **GVMS Dr. Dada Vaidya College of Education, Plot No. 276/o, street/Road-Farmagudi, Village-Bandora, Post Office-Ponda, District-North Goa, State-Goa-403401** for the M.Ed. 2 -Years programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
