Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Savitribai Phule Pune University, Plot No. 1/1/1/1/1A/1, Street-Ganeshkhind, Village-Aundh, Post Office- University, Tehsil-Pune, District- Pune, Maharashtra-411007 had submitted the application to WRC online on 25.05.2015 for grant of recognition to Department Of Education And Extension, Savitribai Phule Pune University, Plot No. 1/1/1/1/1A/1, Street-Ganeshkhind, Village-Aundh, POst Office- University, Tehsil-Pune, District- Pune, Maharashtra-411007 for B.Ed-M.ED (Integrated) course.

And whereas, the proposal was examined and copy of the application was sent to the State Govt. on 17.08.2015 for seeking their comments/recommendation. The State Govt. sent its recommendation vide letter dated-09.10.2015.

And whereas, the matter was placed before the WRC in its 235th meeting held on November 23-24, 2015. The committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 02.12.2015 and institution submitted reply of Show cause notice on 22.12.2015.

And whereas, the matter was placed before the WRC in its 242nd meeting held on 11-13 February, 2016 and the committee decided that VT be constituted.

And whereas, the inspection of the institution was conducted on 06.03.2016.

And whereas, the matter was placed before the WRC in its 248th meeting held on 11-12 April, 2016. The committee decided to issue the Letter of Intent. Accordingly, Letter of Intent was issued to the institution.

And whereas, the reply dated 14.04.2016 submitted by the institution, was received on 30.04.2016.

And whereas, the matter was placed before the WRC in its 251st meeting held on 30 April -02 May, 2016. The committee decided to issue clarification to the University in case of insufficient Faculty on dated 02.05.2016.

And whereas, the reply dated 24.05.2016 submitted by the institution.

And whereas, the matter was placed before the WRC in its 255th meeting held on 22-24, June, 2016. The committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 12.07.2016 and institution did not submit reply of Show cause notice till date.

"Again, the matter was placed before WRC in its 266th meeting held on 10-12 January, 2016 and the committee decided as :-

The case file was seen. Clarification letter/Show Cause Notice dt. 12/07/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."
