Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, R H Patel English Medium B.Ed. College, Plot/Khasara No. LND/EDL/1070/56085(51)/R1, Street Number - Near Gh-6, Village - Gandhinagar, Post office - Sector-23, Tehsil/Taluka - Gandhinagar, District - Gandhinagar- 382023, Gujarat had applied on 03.06.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting B.Sc.B.Ed.(Integrated) Course.

And whereas, file was scrutinized and the document found in order. Keeping in view of the decision taken in 247th WRC meeting, VT constituted.

And whereas, the inspection of institution was conducted on 13.04.2016.

And whereas, WRC considered visiting team report along with regulatory file and other relevant document placed in 249th meeting held on 21st - 13th April, 2016 and committee decided to issue SCN. Accordingly, SCN was issued to the institution on 01.05.2016, and reply was submitted by the institution on dt. 12.05.2016

And whereas, the case was placed in 255th meeting held on 22nd - 24th June, 2016 and committee decided to issue SCN. Accordingly, SCN was issued to the institution on 28.06.2016, and reply was submitted by the institution on dt. 06.09.2016

And whereas, the case was placed in 269th meeting held on 21st - 23rd February, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. For all the teacher education courses which are being currently run in the college, the required built up area is 6500 sq. mtrs. The building currently has a total built up area of 6697 sq. mtrs. subject to verification certificate of building completion issued by a Govt. Engineer. Further, the institution is running around 29 other courses. The institution should submit a Building Plan showing the location of all the courses including teacher education courses.

Therefore, the application of the institution for 2 units of the B.Sc.B.Ed. course cannot be considered.

Therefore, Recognition for the B.Sc.B.Ed. course is refused.

The WRC also recommends that the NCTE Hqrs. be requested to conduct a comprehensive VT under section 13 to get actual facts on the ground."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to the R H Patel English Medium B.Ed. College, Plot/Khasara No. LND/EDL/1070/56085(51)/R1, Street Number - Near Gh-6, Village - Gandhinagar, Post office - Sector-23, Tehsil/Taluka - Gandhinagar, District - Gandhinagar- 382023, Gujarat.**
