Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993 Shree Swaminarayn B.Ed./M.Ed. College, Plot/ Street Number -197, Village/Post office/tehsil/Taluka - Vijapur, District- Mehsana-382870, Gujarat, had applied on 29.05.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting B.Ed.M.Ed. (Integrated) 4 Year Course.

And whereas, file was scrutinized and the document found in order. Keeping in view of the decision taken in 247th WRC meeting, VT constituted.

And whereas, the inspection of institution was conducted on 14.04.2016.

And whereas, WRC considered visiting team report along with regulatory file and other relevant document placed in 249th meeting held on 21th - 23rd April, 2016 and committee decided to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 01.02.2016, and reply was submitted by the institution on dt. 26.02.2016, and reply is not submitted by the institution within 30 days as per Show Cause Notice.

And whereas, the case was placed in 266th meeting held on 10th-12th January, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. Clarification letter/Show Cause Notice dt. 01/05/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to the Shree Swaminarayn B.Ed./M.Ed. College, Plot/ Street Number -197, Village/Post office/tehsil/Taluka - Vijapur, District- Mehsana-382870, Gujarat.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
