REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, All India Society For Electronics And Computer Technology, Plot / Khasra No 0, Village- Bhaironpur, Post+Teh/Taluka-Misrod, City/Town- Bhopal, Dist- Bhopal - 462026, Madhya Pradesh (WRCAPP2717) had submitted the application on 03.06.2015 to the Western Regional Committee of the NCTE for grant of recognition/permission to Sect College Of Professional Education, Plot / Khasra No 381, 379, Village-Bhaironpur, Post+Teh/Taluka-Misrod, City/Town- Bhopal, Dist- Bhopal - 462026, Madhya Pradesh for M.Ed. 2 years course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 11.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 19.11.2015 has given the recommendation.

AND WHEREAS, in its 241st meeting held on February 4-6, 2016, the WRC decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

AND WHEREAS, application was scrutinized and following deficiencies/shortcomings were observed:-

1. Originally notarized copy of Non-Encumbrance certificate issued by Sub-Registrar submitted but it is in the name of shri Santosh S/o Sh. Jagannath Choubey.
2. FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.

AND, WHEREAS, the Show Cause Notice was issued on 16.02.2016 on the above grounds.


AND WHEREAS, the reply dt. 23.02.2016 of the Institution was placed before WRC in its 244th meeting held on February 25-26, 2016. The Committee decided that "...The institute is running the B.Ed. course with two units vide order No. WRC/2-32/60/2004/3903 dated 10.06.2004. This case relates to the M.Ed. course. The institute has submitted all the documents except that the Non-Encumbrance Certificate does not have the signature of the notary public.

Hence, VT be constituted and it should collect the non encumbrance certificate originally signed and sealed by the notary public."

AND WHEREAS, the Visiting Team visited the institution on 28.03.2016.

AND WHEREAS, the visiting team report alongwith other documents, were placed before WRC in its 249th meeting held on April 21-23, 2016. The Committee decided that "... the VT report was perused but the CD could not be viewed. The institution be asked to send another CD in proper condition."

AND WHEREAS, the Letter for obtaining another CD was issued on 27.04.2016. The Institution has submitted new CD.

AND WHEREAS, the matter was placed before WRC in its 250th meeting held from April 27-28, 2016. The Committee decided that "...The case was considered in the 249th meeting of the WRC. The CD sent by the VT could not be viewed. The Society was asked to send another CD in proper condition. The Society has submitted another CD. The CD was run and it was found to be blank. The Society be informed to send the new CD that contains the videography."

AND WHEREAS, the Letter for obtaining another CD was issued on 29.04.2016

AND WHEREAS, the reply of Institution dt. 29.04.2016 (On the basis of Minutes uploaded on WRC website) was placed before WRC in its 251st meeting held from April 30- May 2, 2016. The Committee decided that LOI be issued for one unit of the M.Ed. course.

AND WHEREAS, the LOI was issued on 01.05.2016. Reply submitted by institution on 02.05.2016 (7.15 PM)

AND WHEREAS, the reply of LOI submitted by institution was placed before WRC in its 255th meeting held from June 22-24, 2016. The Committee decided that:-

"...LOI dt. 01/05/2016 was issued. The reply and documents submitted by the applicant were examined. The following lacunae were observed:-

- i) FDRs of Rs. 5 and 7 lakhs have not been submitted;
- ii) Staff profile duly approved by the affiliating body has not been submitted. Only a provisional faculty list without approval of affiliating body has been submitted;
- iii) Experience certificate of the Principal/HOD has not been submitted;
- iv) The Affidavit to be submitted by management has been submitted by the Principal, and not by the management;
- v) The list submitted by the Principal does not tally with the staff list;
- vi) The lecturer mentioned at serial no.8 does not have the required percentage of 55 at PG level.


Hence, Show Cause Notice be issued on the above grounds."

AND, WHEREAS, the Show Cause Notice was issued on 11.07.2016 and the reply not received from the institution.

AND WHEREAS, the matter was placed before WRC in its 258th meeting held on August 22-24, 2016. The Committee decided that "...The applicant institution had applied for Recognition of M.Ed. course. Letter of Intent dt. 01/05/2016 was issued. However, vide letters dt. 26/07/2016 and 11/08/2016, the applicant has requested for cancellation of its request for M.Ed. course Recognition. A Resolution of the Society has not been submitted. A Resolution be obtained.

Attention of the institution be drawn to Section 2(b), 3 & 8 of the NCTE Regulations, 2014 according to which all teacher education institutions are required to be composite. This is with reference to the B.Ed. course being conducted."

AND WHEREAS, the Clarification letter was issued on **31.08.2016** and the reply received from the institution on 15.09.2016.

AND, WHEREAS, the reply of the Institution was placed before WRC in its **270th meeting held on March 01-03, 2017**. The Committee decided that *"....The institution has submitted a resolution from the management for closure of the M.Ed. course. Hence, Recognition is refused. FDRs if any, be returned."*

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **Sect College Of Professional Education, Plot / Khasra No 381, 379, Village- Bhaironpur, Post+Teh/Taluka-Misrod, City/Town- Bhopal, Dist- Bhopal - 462026, Madhya Pradesh** for the **M.Ed. 2 -Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
