Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Shri Hari Education And Charitable Trust, Plot/Khasra No. 207/1P-2/P-1, Street No. 207/1, Village - Khadiya, Post Office - Toraniya, Tehsil/Taluka - Junagadh, District - Junagadh, Gujarat - 362263 had applied on 03.06.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting B.Sc.B.Ed.(Integrated) Course.

And whereas, file was scrutinized and the document was found in order. Keeping in view of the decision taken in 247th WRC meeting, VT was constituted.

And whereas, the inspection of institution was conducted on 17.04.2016 & 18.04.2016.

And whereas, WRC considered visiting team report along with regulatory file and other relevant document placed in 249th meeting held on 21st - 13th April, 2016 and committee decided to issue LOI. Accordingly, LOI was issued to the institution on 26.04.2016, and reply was not submitted by the institution.

And whereas, the case was placed in 264th meeting held on 14th - 15rd December, 2016 and committee was decided to issue Show Cause Notice dt. 20.12.2016, and reply was not submitted by the institution.

And whereas, the case was placed in 269th meeting held on 21st - 23rd February, 2017 and committee was decided to issue refusal order to the institution on the following points:-

"The case file was seen. Consequent to the issue of LOI dt. 26/04/2016, the institution has not submitted any reply. Thereafter, Show Cause Notice was issued on 20/12/2016 to which also reply was not received.

Hence, Recognition is refused. FDRs, if any be returned."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to the Amrut Institute Junagadh, Plot/Khasra No. 207/1P-2/P-1, Street No. - 207/1, Village-Khadiya, Post Office - Toraniya, Tehsil/Taluka - Junagadh, District - Junagadh, Gujarat-362263.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
