REFUSAL ORDER

Whereas in terms of section 15 of the NCTE Act, 1993, **Guru Govind Singh Tricentenary, Plot No: 22/25/26/1, Street/Road: Dewas Road Ujjain, Village : Chandesari, Post Office: Motilal Nehru Nagar, Tehsil + City: Ujjain, District: Ujjain 456010 Madhya Pradesh** had submitted the application on **29.05.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Maharaja College, Plot No : 22/25/26/1, Street : Dewas Road, Village : Chandesari, Post Office : Motilal Nehru Nagar, Tehsil + City: Ujjain, District: Ujjain, 456010, Madhya Pradesh** for conducting the **B.Ed.M.Ed. 3 Years integrated programme.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on **13.07.2015** requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated **09.10.2015** has given the recommendation.

AND WHEREAS, in its **241st meeting of the WRC held on February 4-6, 2016** it was decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

AND WHEREAS, application was scrutinized and following deficiencies/shortcomings were observed:-

1. Original certified copy of registered land documents issued by the competent authority as required under provision of section 8 (4) (i) of NCTE, Regulations, 2014 not submitted.
2. Photo copy of building plan submitted but Total land area, name of Society/ Institution not mentioned, size of multipurpose hall, class room not readable, Blue print/ notarized copy of approved building plan issued by the competent authority not submitted.
3. Building permission dt. 11.07.2007 issued by Sarpanch submitted as CLU. Notarized copy of change of land use certificate issued by the competent authority/SDO not submitted.
4. Affidavit submitted but date of Registration of land not mentioned.
5. Copy of Registration, Memorandum, By-laws of the society / trust not submitted.
6. Photo copy of Non encumbrance certificate submitted but, Khasara no., Total land area not mentioned & not notarized.
7. Notarized copy of Building completion certificate not submitted.
8. Fixed deposit receipt of Rs. Five lakhs in original from Nationalized Banks towards Endowment Fund not submitted.
9. Fixed deposit receipt of Rs. Seven lakhs in original from Nationalized Banks towards Reserve Fund not submitted.

AND WHEREAS, the Show Cause Notice was issued on **12.02.2016.**

AND WHEREAS, the reply dt. **02.03.2016** of the Institution was placed before WRC in its **249th meeting held on April 21-23, 2016.** The Committee decided that *"....An examination of the file shows that the institution has not submitted originally certified copy of land documents. Hence, Clarification be obtained on the above ground."*

AND WHEREAS, the Clarification letter was issued on **26.04.2016.**

AND WHEREAS, the reply dt. **26.04.2016** of the Institution was placed before WRC in its **251st meeting held on April 30 - May 02, 2016**. The Committee decided that *"....In the 249th meeting, the institution was asked to submit originally certified copy of the land documents. The institution vide reply dt. 25/04/2016, has submitted the originally certified copy of the land documents. Hence, VT be constituted."*

AND WHEREAS, the Visiting Team visited the institution on **19.05.2016**.

AND WHEREAS, the visiting team report alongwith other document, were placed before WRC in its **254th meeting held on June 07-09, 2016**. The Committee decided that *"...The VT visited the institution on 19/05/2016. The VT report was perused and CD viewed. The CD shows a good building with adequate infrastructural and instructional facilities. However, the institution has 5674 sq. mtrs. built up area which is not sufficient to run the existing two units of the D.Ed. course(222076), two units of the B.Ed. course(223186), one unit of the M.Ed. course(225110) (requirement is 4500 sq. mtrs.) and the proposed additional unit of D.El.Ed. course and the B.Ed.M.Ed. integrated course (requirement is 2000 sq. mtrs.). Hence, Show Cause Notice be issued on the above grounds."*

AND WHEREAS, the Show Cause Notice was issued on **13.06.2016**.

AND WHEREAS, the reply dt. **21.06.2016, 12.07.2016 & 26.07.2016** of the Institution were placed before WRC in its 258th meeting held on August 22-24, 2016. The Committee decided that *"...Show Cause Notice dt. 13/06/2016 was issued on the ground of built up area being less. In the reply, the institution has explained the position regarding the availability of built up area which is acceptable. Hence, LOI be issued for one unit of B.Ed.M.Ed. (APP2747) and one additional unit of D.El.Ed. (APP2755) course."*

AND WHEREAS, the Letter of Intent was issued on **31.08.2016**.

AND WHEREAS, the reply dt. 29.09.2016 of the Institution was placed before WRC in its 264th meeting held on December 14-15, 2016. The Committee decided that *"...Consequent to the issue of LOI, the institute has identified 7 faculty members from the existing M.Ed. course, 1 faculty member from the B.Ed. course and 2 others. Each course must have independent staff according to the nature of the course and work load. Hence, Show Cause Notice be issued as to why the application for the integrated B.Ed.M.Ed. course be refused on the ground of non availability of staff."*

AND WHEREAS, the Show Cause Notice was issued on **20.12.2016**.

AND WHEREAS, the reply dt. **06.01.2017** of the Institution was placed before WRC in its **269th meeting held on February 20-22, 2017**. The Committee decided that *"...Show Cause Notice was issued to the institution on 20/12/2016. The institution vide its reply dt. 06/01/2017 has submitted a photocopy containing the list of 4 faculty members without any certificates about their experience.*

The institution should submit the originally approved list and experience certificates etc.


On receipt of the above, the case will be considered further.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, the Clarification letter was issued on **28.02.2017**.

AND WHEREAS, the reply dt. **02.03.2017** of the Institution was placed before WRC in its **271st meeting held on March 23-25, 2017**. The Committee decided that *"...Consequent to the issue of LOI, the institution has submitted a list of one Principal and four faculty members. This matter was referred to the NCTE hqrs. and NCTE hqrs. vide letter dated 17.03.2017 has clarified that full staff should be appointed. The institution should submit full faculty staff.*

Hence, Show Cause Notice be issued as to why the Recognition should not be refused on the above grounds. Reply should be submitted within 30 days.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND WHEREAS, the Show Cause Notice was issued on **03.04.2017**.

AND WHEREAS, the reply dt. **11.04.2017** of the Institution was placed before WRC in its **275th meeting held on May 1-2, 2017**. The Committee decided that "...In response to the Show Cause Notice regarding the appointment of staff, the institution has submitted a list of 1 Principal, 1 Professor, 3 Associate Professors, and 5 Assistant Professors. Out of these the faculty members at serial nos. 1, 3, 4, 5, 6, 7, and 8 are common with the existing M.Ed. and B.Ed. courses. This is not permissible under NCTE Regulations. Secondly, the list is not approved by the competent authority.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **Maharaja College, Plot No: 22/25/26/1, Street: Dewas Road, Village: Chandesari, Post Office: Motilal Nehru Nagar, Tehsil + City: Ujjain, District: Ujjain, 456010, Madhya Pradesh** for the **B.Ed.M.Ed. 3 -Years integrated programme**.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
