REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **Tanmay Shiksha Evam Samaj Kalyan Samiti Bhopal, Plot / Khasra No 209, Street/Road- Ratibad Road, Village- Server, Post - Suraj Nagar, Teh. - Huzur, City/Town- Bhopal, Dist- Bhopal - 462044, Madhya Pradesh (WRCAPP2764)** had submitted the application on **29.05.2015** to the Western Regional Committee of the NCTE for grant of permission to **Raghukul College of Education, Plot /Khasra No 209, Street/Road- Ratibad Road, Village - Server, Post - Suraj Nagar, Teh. - Huzur, City/Town- Bhopal, Dist- Bhopal - 462044, Madhya Pradesh** for **M.Ed. 2 years course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 10.12.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in 241st meeting of the WRC held on February 04-06, 2016 it was decided as under:

"...The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

Hence, in view of the above, Show Cause Notice dt. 16.02.2016 was issued to the institution/society on the following grounds:-

1. Originally certified copy of registered land documents not submitted.
2. Originally notarized copy of Non-Encumbrance certificate issued by Tehsildar, SDO, and Sub-Registrar not submitted.
3. FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
4. NOC from affiliating body not submitted.
5. As per online application institution has not given any details of running/applied Teacher training programme and other than teacher training programme."

AND WHEREAS, the reply dt. 18.03.2016 submitted by Institution was placed before WRC in its 249th meeting held on April 21-23, 2016. The Committee decided that "...Show Cause Notice was issued to the institution on 16/02/2016 and the reply was received on 18/03/2016. A scrutiny of the reply shows that the institution has submitted all the required documents. **Hence, VT be constituted.**"

AND WHEREAS, the Visiting Team constituted through online mode. One VT member Dr. Yash Pal Singh vide his email dt. 27.09.2016 has stated that "...This inspection was to be done by me and Prof. Suraksha Pal of Meerut. We both contacted the college on the phone number provided by WRC and requested inspection on September 14 and 15, 2016. However, the college refused for the inspection and said that they are not willing to start the M.Ed. program applied by them earlier."

AND WHEREAS, the matter was placed before WRC in its 270th meeting held on March 01-03, 2017. The Committee decided that "...The VT was constituted however, the management refused for inspection. **Show Cause Notice be issued on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 10.03.2017. Reply has not been submitted by institution.

AND WHEREAS, the matter of reply has not been received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice/Clarification letter was issued on 10.03.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses permission to **Raghukul College of Education, Plot /Khasra No 209, Street/Road- Ratibad Road, Village - Server, Post -Suraj Nagar, Teh. - Huzur, City/Town- Bhopal, Dist- Bhopal - 462044, Madhya Pradesh** for the **M.Ed. 2 - Years** programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
