Whereas in terms of Section 15 of the NCTE Act, 1993, Shri Prabhas Kelavani Mandal, Plot Number - 1862, Street/Road - Veraval-Kodinar Road, Village/Town/City- Prabhas Patan, Post office - Prabhas Patan, Tehsil/Taluka - Veraval, District-Junagadh, Gujarat - 362268 had submitted the application on 29.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to Shri Swaminarayan B.Sc. B.Ed. College, Plot/Khasara No. - 1862, Street Number - 1862, Village - Prabhas Patan, Post office - Prabhas Patan, Tehsil/Taluka - Veraval, District-Junagadh, Gujarat - 362268. for B.A./B.Sc. B.Ed. 04 years Integrated course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 22.01.2016, and reply was not submitted by the institution.

And whereas, the matter was placed in 247th meeting held on 04 - 06th April, 2016 and the Committee decided to refuse recognition to the institution on the following points:-

"The institution is running the B.Ed. with two units and has now applied for the B.A.B.Ed./B.Sc. B.Ed. course. Show Cause Notice was issued to the institution on 21/01/2016. Reply has not yet been received.

Hence, Recognition is refused. FDRs if any, be returned."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, **the Western Regional Committee hereby refuses f recognition to Shri Swaminarayan B.Sc. B.Ed. College, Plot/Khasara No. - 1862, Street Number - 1862, Village - Prabhas Patan, Post office - Prabhas Patan, Tehsil/Taluka - Veraval, District-Junagadh, Gujarat - 362268 for B.A./B.Sc. B.Ed. 04 years Integrated course.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
