REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, MAHARISHI SHIKSHA SANSTHAN, E-5 FLOOR, HANSALAYA BUILDING 15, BARAKHAMBHA ROAD, NEW DELHI- 1 had submitted the online application on 29.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to MAHARISHI SHIKSHA SANSTHAN (DEPARTMENT OF EDUCATION), PLOT NO- 39/4, VILLAGE- LAMTI, POST OFFICE- VIJAY NAGAR, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT: JABALPUR- 482002, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 21.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 235th Meeting held on November 23-24, 2015 and the Committee observed that "...The College applied online on 29.05.2015. However, the hard copy was received on 15.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection letter was issued on 03.12.2015.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Rejection letter dated 03.12.2015 and the Council vide order dated 18.04.2016 remanding the case to WRC.

AND WHEREAS, an appeal order was placed before the WRC in its 254th Meeting held on June 7-9, 2016 and the Committee observed that "...This is a case of Appeal. The Appellate authority vide order dt. 18/04/2016 remanded the case to the WRC. An analysis of the file shows the following deficiencies:-

- i) In the NOC of the University/Affiliating body, the course mentioned is B.Ed. & B.A.B.Ed.
- ii) Notarized copy of Society Registration Certificate and Bye-Laws not submitted.
- iii) Original copy of Affidavit not submitted.
- iv) Photocopy of Land Documents submitted but certified copy not submitted.
- v) Photocopy of Building Plan submitted but Blue-print/Notarized copy not submitted and details not mentioned.
- vi) Notarized copy of Building Completion Certificate not submitted.
- vii) Photocopy of CLU submitted but notarized copy not submitted and total diverted land area is not clear.
- viii) Notarized copy of Non-Encumbrance Certificate not submitted.
- ix) FDRs not submitted as per NCTE norms.

Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, the Show Cause Notice was issued to the institution on 15.06.2016 and the reply was received on 14.07.2016.

AND WHEREAS, the reply was placed before the WRC in its 262nd Meeting held on November 10-11, 2016 and the Committee observed that "...The Show Cause Notice was sent to the institution on 15.06.2016. While the institute has submitted most of the documents, it is seen that the originally certified copy of the registered land documents (only notarized copy submitted) and Building Completion Certificate have not been submitted.

Hence, Clarification be issued on the above grounds. The reply should be submitted within 30 days."

AND WHEREAS, the Clarification letter was issued to the institution on **16.11.2016** and the reply was received on **14.12.2016**.

AND WHEREAS, the reply was placed before the WRC in its 265th Meeting held on December 27-29, 2016 and the Committee observed that "...In response to the clarification letter, the institution has submitted land documents. However, the Building Completion Certificate issued by the competent authority (Sarpanch/Engineer of the RES) has not been submitted. **VT be constituted for the B.Ed. (APP2776) and the B.A.B.Ed. course (APP2798). The VT should obtain a proper Building Completion Certificate from the management.**"

AND WHEREAS, the inspection conducted of the institution on **01.03.2017** and VTR received in office on **06.03.2017**.

AND WHEREAS, the VTR was placed before the WRC in its 271st Meeting held on March 23-25, 2017 and the Committee observed that "...VT visited the institution on 01.03.2017. VTR was perused and the CD was viewed. CD shows a good building with good infrastructural and instructional facilities. VT has recommended the case.

Hence, LOI be issued for one unit of B.Ed. and one unit of B.A. B.ED. course.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND WHEREAS, an information letter sent to the institution on **01.03.2017** asked to submit the latest CLU Premium receipt and the reply was received in office on **12.04.2017**.

AND WHEREAS, the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on **31.03.2017** and the reply was received on **28.04.2017**.

AND WHEREAS, the reply was placed before the WRC in its 275th Meeting held on May 1-2, 2017 and the Committee observed that "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal, and 7 faculty members.

However, the subjects at the PG level have not been given for most of the staff.

Secondly, the Registrar of the University has not approved the list saying that the appointments were not made as per Code 28.

Hence, Show Cause Notice be issued on the above grounds.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND WHEREAS, the Show Cause Notice was not issued to the institution (**uploaded on website**) and the reply was received on **02.05.2017**.

AND WHEREAS, the reply was placed before the WRC in its 275^h Meeting held on May 1-2, 2017 and the Committee observed that "...Show Cause Notice was issued on the ground that the Registrar had not approved the list and the subjects at the PG level were not given.

The institution has replied with the approval of the Registrar but subjects at the PG level have still not been given.


Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **MAHARISHI SHIKSHA SANSTHAN (DEPARTMENT OF EDUCATION), PLOT NO- 39/4, VILLAGE- LAMTI, POST OFFICE- VIJAY NAGAR, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT: JABALPUR- 482002, MADHYA PRADESH** for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
