REFUSAL ORDER

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, **Maharishi Shiksha Sansthan, Plot No.: 39/4, Street/Road: Kanchan Vihar, Vill.: Lamti, P.O.: Vijay Nagar, Tehsil/Taluka + City: Jabalpur, Dist.: Jabalpur 482002, Madhya Pradesh (WRCAPP2798)** had submitted the application on **29.05.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Maharishi Shiksha Sansthan (Department of Education), Plot No.: 39/4, P.O.: Vijay Nagar, City: Gram - Lamti, Dist.: Jabalpur 495001, Madhya Pradesh** for **B.A.B.Ed. 4 years integrated course.**

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 13.08.2015 requesting to give their recommendation/ comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 233rd meeting held on October 8-9, 2015 and the Committee decided to reject the application due to the reason that the institution has submitted the printout of the application after 15 days of the submission of the online application. Regulation 7 of NCTE Regulations, 2014 mandates that the printout of the application should be submitted within 15 days of the submission of the online application. Accordingly, rejection letter was issued to the institution on 21/10/2015.

AND WHEREAS, institution preferred an appeal against the rejection letter dt. 21.10.2015 and the council remanded back the case to WRC, NCTE with a direction to reconsideration of the case.

AND WHEREAS, the matter was placed before the WRC in its 254th meeting held on June 7-9, 2016, the committee observed that:-

"...This is a case of Appeal. The Appellate authority vide order dt. 18/04/2016 remanded the case to the WRC. An analysis of the file shows the following deficiencies:-

- i) FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
- ii) Originally certified copy of registered land documents not submitted.
- iii) Notarized copy of Building Plan not submitted. Photocopy of Building Plan submitted but details of khasra no. , Built- up area etc not mentioned.
- iv) Notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer not submitted.
- v) Original Affidavit on Rs. 100/- in the prescribed Proforma not submitted.
- vi) Notarized Copy of registration, Memorandum, By-laws of the society/trust not submitted.
- vii) Notarized copy of Non-Encumbrance certificate issued by Tehsildar, SDO, Sub-Registrar not submitted.
- viii) Building Completion Certificate issued by Govt. Engineer/RES not submitted.
- ix) The Society should clarify which course it wants to run i.e. B.A.B.Ed. or B.Sc.B.Ed.

Hence, Show Cause Notice be issued on the above grounds."

AND, WHEREAS, the Show Cause Notice was issued on **16.06.2016** on the above grounds.

AND WHEREAS, the reply dt. **14.07.2016** of the Institution was placed before WRC in its **262nd meeting held on November 10-11, 2016**. The Committee decided that *"....The Show Cause Notice was sent to the institution on 16.06.2016. While the institute has submitted most of the documents, it is seen that the originally Certified copy of the Registered land documents (only notarized copy submitted) and Building Completion Certificate have not been submitted.*

Hence, Clarification be issued on the above grounds. The reply should be submitted within 30 days."

AND, WHEREAS, the Clarification letter was issued on **27.11.2016** on the above grounds.

AND WHEREAS, the reply dt. **14.12.2016** of the Institution was placed before WRC in its **265th meeting held on December 27-29, 2016**. The Committee decided that *"....In response to the clarification letter, the institution has submitted land documents. However, the Building Completion Certificate issued by the competent authority (Sarpanch/Engineer of the RES) has not been submitted.*

VT be constituted for the B.Ed. (APP2776) and the B.A.B.Ed. course (APP2798). The VT should obtain a proper Building Completion Certificate from the management."

AND WHEREAS, the Visiting Team visited the institution on **01.03.2017**.

AND WHEREAS, the visiting team report alongwith other documents, were placed before WRC in its **271st meeting held on March 23-25, 2017**. The Committee decided that *"...VT visited the institution on 01.03.2017. VTR was perused and the CD was viewed. CD shows a good building with good infrastructural and instructional facilities. VT has recommended the case.*

Hence, LOI be issued for one unit of B.Ed. and one unit of B.A. B.ED. course.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND WHEREAS, the LOI was issued on **03.04.2017**. Reply submitted by institution on **28.04.2017**.

AND WHEREAS, the reply of LOI submitted by institution was placed before WRC in its **275th meeting held on May 1-2, 2017**. The Committee (on 1st day) decided that:-

"...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal, and 7 faculty members. However, the subjects at the PG level have not been given for most of the staff.

Secondly, the Registrar of the University has not approved the list saying that the appointments were not made as per Code 28.

Hence, Show Cause Notice be issued on the above grounds.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

AND, WHEREAS, the Show Cause Notice not issued. The reply received from the institution on **02.05.2017** (as per the minutes uploaded on the website of NCTEWRC.)

AND, WHEREAS, the reply of the Institution was placed before WRC in its **275th meeting held on May 1-2, 2017 (2nd day)**. The Committee decided that "...Show Cause Notice was issued on the ground that the Registrar had not approved the list and the subjects at the PG level were not given.

The institution has replied with the approval of the Registrar but subjects at the PG level have still not been given. Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition of **Maharishi Shiksha Sansthan (Department of Education), Plot No.: 39/4, P.O.: Vijay Nagar, City: Gram - Lamti, Dist.: Jabalpur 495001, Madhya Pradesh** for the **B.A.B.Ed. 4 -Years integrated programme**.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
