## REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993 LAXMIPATI COLLEGE, PLOT/KHASARA NO: 725,726,727,728,767/1K, STREET: NEW SOS, VILLAGE: KHAJURI KALAN, POST OFFICE: PIPLANI, TEHSIL: HUZUR, DISTRICT: BHOPAL- 462021, MADHYA PRADESH had submitted the application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 239<sup>th</sup> Meeting held on January 6-8, 2016 and the Committee observed that "...This applicant has already applied for B.P.Ed. course (APP2808). The land documents submitted in this file for two units of B.Ed. (APP2806) are the same as in the B.P.Ed. file.

Hence, attention of the applicant is invited to clause 6.2 (i) of Appendix 7 in which it is written that other teacher education courses cannot be run alongwith the physical education courses.

Apart from this, it is necessary to mention that the applicant does not have sufficient land area and built up area for B.P.Ed. and two units of B.Ed. The other documents submitted by the applicant viz. CLU, building plan, non-encumbrance certificate, and no objection certificate is not originally notarized and building completion certificate not submitted.

**Hence, Show Cause Notice be issued on the above grounds.**

State Government has not recommended the case, however, as per the public notice dated 27.02.2015, only a few districts are closed for only D.El.Ed. course. All other courses are open in Madhya Pradesh."

AND WHEREAS, the Show Cause Notice was issued to the institution on 15.01.2016 and the reply was received on 12.02.2016.

AND WHEREAS, the reply was placed before the WRC in its 243<sup>rd</sup> Meeting held on February 18-20, 2016 and the Committee observed that "...The VT inspected the premises on 07/02/2016.

The CD shows good physical and academic infrastructure. The VT has recommended the case. The VT has reported the availability of 3000 sq. mtrs built up area, which is less, if the B.P.Ed. course, and two units of B.Ed. are considered. Hence, this case is being considered only for one unit of B.Ed. course.

**Hence, Clarification be obtained on this point.**

**The applicant should also submit a notarized Building Completion Certificate from an Engineer from the Municipal Corporation, Bhopal. FDRs also be obtained.**

As regards, the point made about physical education courses to be run singly in the Show Cause Notice dt. 15/01/2016 of the WRC, it has been informed that this clause is under amendment as per the NCTE Hqrs. Committee minutes dt. 31/08/2015. Hence, this point is dropped."

AND WHEREAS, the Clarification letter was issued to the institution on 23.02.2016 and the reply was received on 27.02.2016.

AND WHEREAS, the reply was placed before the WRC in its 245<sup>th</sup> Meeting held on March 01-03, 2016 and the Committee observed that "...The applicant submitted application for two units of B.Ed. course. As the institution did not have required built up area, clarification was obtained whether it wants to run one unit of B.Ed. course. It was also asked to submit notarized Building Completion Certificate from an engineer from the municipal body.

The applicant institution, in its reply, has submitted that the case be considered for one unit of B.Ed. course. It has also submitted the Building Completion Certificate which is in order.

**Hence, LOI be issued for one unit of B.Ed. course.**

**The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 3<sup>rd</sup> March, 2016, can the case be considered for the session 2016-2017."**

**AND WHEREAS**, the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on **02.03.2016** and the reply was received on **01.05.2016**.

**AND WHEREAS**, the reply was placed before the WRC in its 251<sup>st</sup> Meeting held on April 30-May 2, 2016 and the Committee observed that "...Consequent to the issue of LOI, the institution has submitted a list of 11 Assistant professors, who are qualified and approved by the affiliating body.

However, this case cannot be considered at this stage because Show Cause Notice has been issued to its B.P.Ed. Course (APP2808)."

**AND WHEREAS**, the letter was issued to the institution on **06.05.2016** and the reply was received on **09.06.2016**.

**AND WHEREAS**, the reply was placed before the WRC in its 264<sup>th</sup> Meeting held on December 14-15, 2016 and the Committee observed that "...Consequent to the issue of LOI the institute has submitted a list of 1 Principal and 10 faculty members, qualified and approved by the competent authority. It is noticed that the institute has not appointed a Principal. When this case matures it should be put up together with the B.P.Ed. Course (APP2808).

**Hence, Show Cause Notice be issued on the above ground."**

**AND WHEREAS**, the Show Cause Notice was issued to the institution on **19.12.2016** and the reply was received on **09.01.2017**.

**AND WHEREAS**, the matter was placed before the WRC in its 268<sup>th</sup> Meeting held on February 09-11, 2017 and the Committee observed that "...In the 251<sup>st</sup> meeting and the 264<sup>th</sup> meeting, the WRC has asked the institution to submit the required staff for the B.P.Ed. course i.e. one Principal/HOD, 2 Associate Professors and six Assistant Professors (Appendix-7 of NCTE Regulations, 2014). In spite of repeated Show Cause Notices, the institution has not appointed staff as per NCTE requirement. **Hence, Recognition is refused for B.P.Ed. course.**

And since the Recognition for B.P.Ed. course is refused, the institution has become stand-alone which is not permitted as per clause 2(b) and 3(a) of the NCTE Regulations, 2014.

**Hence, Show Cause Notice be issued as to why the recognition should not be refused on the above grounds. Reply should be submitted within 30 days."**

**AND WHEREAS**, the Show Cause Notice was issued to the institution on **15.02.2017** and the reply was received on **14.03.2017**.

**AND WHEREAS**, the matter was placed before the WRC in its 271<sup>st</sup> Meeting held on March 23-25, 2017 and the Committee observed that "...Consequent to the issue of LOI, the institution has submitted a list of one Principal and ten faculty members who are approved by the competent authority. However, all the faculty members do not have PG degree in the teaching subject. All are MA in Education or Psychology. This is not permitted as per Appendix-4 of NCTE Regulations, 2014.

**Hence, clarification be obtained from the institution on the above grounds.**

**Reply should be submitted within 30 days.**

**AND WHEREAS**, the Clarification letter was issued to the institution on **31.03.2017** and the reply was received on **07.04.2017**.

**AND WHEREAS**, the matter was placed before the WRC in its 273<sup>rd</sup> Meeting held on April 18-19, 2017 and the Committee observed that "...In the 271<sup>st</sup> meeting, the WRC had remarked that all faculty members do not have PG degree in the teaching subjects.

The institution has now clarified that all members have a PG Degree in various teaching subjects.

An examination of the staff profile shows that the institution has not appointed a Principal/HOD. The institution has also not complied with the directions.

**Hence, Recognition is refused. FDRs, if any be returned."**

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **LAXMIPATI COLLEGE, PLOT/KHASARA NO: 725,726,727,728,767/1K, STREET: NEW SOS, VILLAGE: KHAJURI KALAN, POST OFFICE: PIPLANI, TEHSIL: HUZUR, DISTRICT: BHOPAL-462021, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website [www.ncte-india.org](http://www.ncte-india.org).


