Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Dr. C.V. Raman College of Education, Plot/Khasra No. 28, Street No. – Kargi Road, Village – Kota, Post Office – Kota, Tehsil/Taluka – Kota, District – Bilaspur, Chhattisgarh - 495113 had submitted the application on 30.05.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting D.El.Ed. (ODL Mode) Course.

And whereas, the proposal was examined and the Show Cause Notice letter was issued to the institution on 09.02.2016, and reply was submitted by the institution on dt. 23.02.2016.

And whereas, the matter was placed in 247th meeting held on 4th - 6th April, 2016 and Committee decided to issue Clarification to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 13/02/016 and the institution has replied on 23/02/2016. The institution has satisfactorily addressed the points of Show Cause Notice.

The attention of the University is drawn to clause 9 of the Appendix-9 of the NCTE Regulations wherein the six pre requisites have been stated. These have to be fulfilled before the case can be considered further. Documentary evidence in this regard should be sent to WRC.

Clarification be obtained from the institution on the above ground."

Accordingly, Clarification letter was issued to the institution on 09.04.2016.

And whereas, institution has not submitted the reply of Clarification letter dt. 09.04.2016 to till date and matter was placed before the WRC in its 266th meeting of WRC held on January 10th – 12th, 2017 and Committee decided to issue refusal order to the institution on following points:

"The case file was seen. Clarification letter/Show Cause Notice dt. 09/04/2016 was issued to the institution. Reply has not been received till date.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to the Dr. C.V. Raman College of Education, Plot/Khasra No. 28, Street No. – Kargi Road, Village – Kota, Post Office – Kota, Tehsil/Taluka – Kota, District – Bilaspur, Chhattisgarh - 495113.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order. 
