**REFUSAL ORDER**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, DPS EDUCATIONAL SOCIETY PLOT NO: 906, STREET: JHANSHI BYPASS ROAD, VILLAGE: RAJAKEDI, POST OFFICE: MAKRONIA, CITY: SAGAR, TEHSIL: SAGAR, DISTRICT: SAGAR-470004, MADHYA PRADESH had submitted the online application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to DPS COLLEGE OF EDUCATION, PLOT NO: 266/6, 266/7, STREET NO: NH-26, VILLAGE: PATHARIYA JAT, POST OFFICE: MAKRONIA, TEHSIL: SAGAR, DISTRICT: SAGAR- 470004, MADHYA PRADESH for starting the B.Ed. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 30.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241<sup>st</sup> Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-  
"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

1. Certified copy of land documents not submitted.
2. Notarized copy of Change of land use (CLU) certificate issued by competent authority not submitted.
3. Photocopy of Non-Encumbrance certificate submitted but it is not notarized.
4. Notarized copy of legible Building plan by the competent authority not submitted.
5. Notarized copy of Building Completion Certificate not submitted.
6. Institute does not fulfill the condition as per clause 2 (b) and 3 (a) of NCTE Regulations, 2014 according to which every teacher training institution has to be a composite institution.
7. FDRs as per NCTE Regulations, 2014 not submitted.
8. NOC from the affiliating body not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 16.02.2016 and the reply was received on 05.07.2016.

AND WHEREAS, the reply was placed before the WRC in its 262<sup>nd</sup> Meeting held on November 10-11, 2016, the committee observed that:- "...The Show Cause Notice was issued to the institution on 16.02.2016.

This case has to be considered together with application for the B.A./B.Sc.B.Ed. course (APP20160280). Otherwise it will be a standalone institution.

Both cases be put up together."

AND WHEREAS, an information letter issued to the institution on 25.11.2016.

AND WHEREAS, the matter was placed before the WRC in its 267<sup>th</sup> Meeting held on January 23-25, 2016 and the Committee observed that "...The DPS Educational Society applied for 2 courses - one is the B.Ed. course (APP2841) and the other for the B.A./B.Sc.B.Ed.(APP201660280) course.

Since, the application for the B.A./B.Sc.B.Ed. course was returned, the application for the B.Ed. course is for a standalone institution which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014.

Hence, Show Cause Notice be issued to the institution on the above ground.

Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 31.01.2017 and the reply was received on 06.03.2017.

**AND WHEREAS**, the matter was placed before the WRC in its 279<sup>th</sup> Meeting held on August 10-11, 2016 and the Committee observed that "...Show Cause Notice was issued on 31.01.2017 regarding the fact that the institute is stand alone. Satisfactory reply has not been received.

**Hence, Recognition is refused.**  
FDRs, if any, be returned."

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **DPS COLLEGE OF EDUCATION, PLOT NO: 266/6, 266/7, STREET NO: NH-26, VILLAGE: PATHARIYA JAT, POST OFFICE: MAKRONIA, TEHSIL: SAGAR, DISTRICT: SAGAR- 470004, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode using website [www.ncte-india.org](http://www.ncte-india.org).
