REFUSAL ORDER

Date: 16/11/14

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, RAO RUKMANI DEVI SHIKSHA SAMITI, PLOT NO: 172/6, STREET: NH26 RAJMARG, VILLAGE: LOLARI, POST OFFICE: LOLARI, TEHSIL: TENDULKEDA, CITY: TENDUKHEDA, DISTRICT: NARSINGHPUR- 487221, MADHYA PRADESH had submitted the online application on 01.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to RAO RUKMANI DEVI INSTITUTE OF TEACHING AND SKILL DEVELOPMENT, PLOT NO: 172/6, STREET: NH26 RAJMARG, VILLAGE: LOLARI, POST OFFICE: LOLARI, TEHSIL: TENDULKEDA, CITY: TENDUKHEDA, DISTRICT: NARSINGHPUR- 487221, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 21.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 235th Meeting held on November 23-24, 2015, the committee observed that: - "...The College applied online on 01.06.2015. However, the hard copy was received on 18.06.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection letter was issued on 03.12.2015.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Rejection letter dated 03.12.2015 and the Council vide order dated 09.06.2016 remanding the case to WRC.

AND WHEREAS, an appeal order was placed before the WRC in its 261st Meeting held on October 26-28, 2016 and the Committee observed that "...This is a case of Appeal. The Appellate Authority vide letter dt. 09/06/2016 has remanded the case to WRC for further processing.

The RD WRO should get this case processed and should put them in the next meeting."

AND WHEREAS, the matter was placed before the WRC in its 263rd Meeting held on November 25-27, 2016, the committee has decided that: - "...An examination of the file shows that the institution has not submitted notarized copy of the Society Registration and Bye-Laws. As land document, it has submitted photocopy of Rent Agreement/Private Lease Deed for 30 years which is not permitted under NCTE Regulations, 2014. It has also not submitted the Building Plan, Building Completion Certificate, CLU and Non-Encumbrance Certificate.

Further, the institution had also applied for the D.El.Ed. course (APP2923) for which Recognition has been refused. Therefore, the institution is a stand alone one which is not permitted under Clause 2(b) of the NCTE Regulations, 2014.

Hence, Show Cause Notice be issued on the above grounds. The reply be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 30.11.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 283rd Meeting held on November 14-15, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 30.11.2016. Further the D.El.Ed. course (APP2923) has been refused recognition. The institution has not replied to the Show Cause Notice till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to RAO RUKMANI DEVI INSTITUTE OF TEACHING AND SKILL DEVELOPMENT, PLOT NO: 172/6, STREET: NH26 RAJMARG, VILLAGE: LOLARI, POST OFFICE: LOLARI, TEHSIL: TENDULKEDA, CITY: TENDUKHEDA, DISTRICT: NARSINGHPUR- 487221, MADHYA PRADESH for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode, using website www.ncte-india.org.
