ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, KESHAR EDUCATION ACADEMY, PLOT NO: 285, WARD NO. 7, STREET: GANDHI NAGAR, TEHSIL: PORSA, CITY: PORSA, DISTRICT: MORENA- 476115 MADHYA PRADESH had submitted the online application on 01.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to KESHAR EDUCATION ACADEMY B.ED. COLLEGE, PLOT NO: 241, 244, STREET: WARD NO- 03, VILLAGE: KONTERKALAN, POST OFFICE: KONTERKALAN, TEHSIL: PORSA, CITY: PORSA, DISTRICT: MORENA- 476115, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, WRC issued Refusal order to KESHAR EDUCATION ACADEMY B.ED. COLLEGE RUN BY KESHAR EDUCATION ACADEMY, PLOT NO: 241, 244, STREET: WARD NO- 03, VILLAGE: KONTERKALAN, POST OFFICE: KONTERKALAN, TEHSIL: PORSA, CITY: PORSA, DISTRICT: MORENA- 476115, MADHYA PRADESH vide order No. WRC/APP2926/223/254th/2016/168890-168896, dated 15.06.2016.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Rejection letter dated 15.06.2016 and the Council vide order dated 02.12.2016 confirms the Order appealed against.

AND WHEREAS, vide Court order dtd. 03.04.2017 in W.P. No. 628/2017 of the Hon'ble High Court of M.P. Bench at Gwalior it has been directed that: "The present petition is disposed of with liberty to the petitioner to submit reply to the show cause notice and to seek composite recognition for the course in accordance with law. However, it is clarified that any finding recorded in the order dtd. 02.12.2016 shall not be taken into consideration for deciding the show cause notice or the claim of the petitioner for grant of recognition."

AND WHEREAS, the matter was placed before the WRC in its 283rd Meeting held on November 14-15, 2017 and the Committee decided that "...The Hon'ble High Court, Bench at Gwalior vide order dated 03.04.2017 in W.P. No.628/2017 had asked the petitioner to reply to the Show Cause Notice issued by the WRC.

The institution till date has not replied to the Show Cause Notice and Refusal order regarding the fact that the D.Ed. course and the B.Ed. course are run in two separate Khasra Nos. which makes the institution stand alone.

Hence, the Refusal of Recognition stands."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby Refusal of Recognition stands to KESHAR EDUCATION ACADEMY B.ED. COLLEGE, PLOT NO: 241, 244, STREET: WARD NO- 03, VILLAGE: KONTERKALAN, POST OFFICE: KONTERKALAN, TEHSIL: PORSA, CITY: PORSA, DISTRICT: MORENA- 476115, MADHYA PRADESH for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online Mode, using website www.ncte-india.org.
