



**Refusal Order**

Whereas in terms of Section 15 of the NCTE Act, 1993, Rahod Education Society, Plot No. 1477/1, 1427/3, Street/Road- Bilaspur To Sheorinarayan, Village- Rahod, Post office-Rahod, Tahsil/Taluka- Pamgarh, District- Janjgir - Champa, Chhattisgarh- 495556 had submitted the application on 05.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Indira Gandhi Arts & Science College, Plot No.- 1477/1, 1427/3, Street No. NH-30, Village- Rahod, Post office- Rahod, Tehsil/Taluka- Pamgarh, District- Janjgir-Champa, Chhattisgarh- 495556 for B.A./B.Sc. B.Ed. 04 years Integrated course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was not submitted by the institution.

And whereas, the matter was placed in 247<sup>th</sup> meeting held on 04 - 06<sup>th</sup> April, 2016 and the Committee decided to refuse recognition to the institution on the following points:-

"Show Cause Notice was issued to the institution on 09/02/2016. Till date no reply has been received.

**Hence, Recognition is refused. FDRs if any, be returned."**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, **the Western Regional Committee hereby refuses recognition to Indira Gandhi Arts & Science College, Plot No.- 1477/1, 1427/3, Street No. NH-30, Village- Rahod, Post office- Rahod, Tehsil/Taluka- Pamgarh, District- Janjgir-Champa, Chhattisgarh- 495556 for B.A./B.Sc. B.Ed. 04 years Integrated course.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
