REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, ABHIRAJ LOK KALYAN SAMITI, PLOT NO- 5A, STREET- RAGHVENDRA NAGAR, KUWAR BABA ROAD, VILLAGE- MAHALGAON, POST OFFICE- RAILWAY STATION, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT- GWALIOR- 474009, MADHYA PRADESH had submitted the online application on 09.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to ABHIRAJ COLLEGE OF EDUCATION, PLOT/ KHASRA NO- 874, 875, STREET- NIRAWALI, VILLAGE- NIRAWALI, POST OFFICE- NIRAWALI, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT- GWALIOR- 474011, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 14.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, the matter was placed before the WRC in its 235th Meeting held on November 23-24, 2015 and the Committee observed that "...The College applied online on 09.06.2015. However, the hard copy was received on 09.07.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

AND WHEREAS, the Rejection letter was issued on 03.12.2015.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Rejection letter dated 03.12.2015 and the Council vide order dated 09.06.2016 remanding the case to WRC.

AND WHEREAS, an appeal order was placed before the WRC in its 261st Meeting held on October 26-28, 2016 and the Committee observed that "...This is a case of Appeal. The Appellate Authority vide letter dt. 09/06/2016 has remanded the case to WRC for further processing.

The RD WRO should get this case processed and should put them in the next meeting."

AND WHEREAS, the matter was placed before the WRC in its 263rd Meeting held on November 25-27, 2016 and the Committee observed that "...An examination of the documents shows that the Society has submitted the Society Registration and Bye-Laws but is not notarized. It has submitted certified copy of land document. It has not submitted notarized copies of Building Plan, Building Completion Certificate, CLU, and Non-Encumbrance Certificate. Further, it is seen that this college is a stand alone institution which is not permitted under Clause 2(b) of the NCTE Regulations, 2014.

Hence, Show Cause Notice be issued on the above grounds. The reply be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 30.11.2016 and the reply received on 30.12.2016.

AND WHEREAS, the reply was placed before the WRC in its 272nd Meeting held on April 6-8, 2017 and the Committee observed that "...In reply to the Show Cause Notice 30/11/2016, the institution vide reply dt. 30/12/2016 has admitted that it is a standalone institution. Further, it has stated that it is going to apply for B.A. in Music and Fine Arts.

If the affiliation letter from the University is received within 1 month, the case will be considered.

Hence, Show Cause Notice be issued as to why the Recognition should not be refused on the above ground."

On observation of the file of the institution the following points be noted:-

1. Notarized copy of Building Plan submitted but name of the institution does not match with online application form.
2. Notarized copy of Building Completion Certificate not submitted.
3. Notarized copy of Change of land use Certificate not submitted.
4. Notarized copy of Non Encumbrance Certificate not submitted.
5. FDRs not submitted as per NCTE Regulation, 2014.

AND WHEREAS, the Show Cause Notice was issued to the institution on 12.04.2017 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 283rd Meeting held on November 14-15, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 12.04.2017. The institution has not replied to the Show Cause Notice till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to ABHIRAJ COLLEGE OF EDUCATION, PLOT/ KHASRA NO- 874, 875, STREET- NIRAWALI, VILLAGE- NIRAWALI, POST OFFICE- NIRAWALI, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474011, MADHYA PRADESH for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode, using website www.ncte-india.org.
