WITHDRAWAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **BUDDHISAGAR EDUCATIONAL SOCIETY, PLOT NO: B-105, STREET: VEENA NAGAR, VILLAGE: SUKHLIYA, POST OFFICE: VIJAY NAGAR, TEHSIL: INDORE, DISTRICT: INDORE-452010, MADHYA PRADESH** had submitted the online application on **11.06.2015** to the Western Regional Committee of the NCTE for grant of recognition to **BUDDHISAGAR COLLEGE, PLOT NO: 979, 982, 983, VILLAGE: JAMLI, POST OFFICE: BADOD, TEHSIL: BADOD, CITY: AGAR- MALWA, DISTRICT: SHAJAPUR- 465441, MADHYA PRADESH** for starting the B.Ed. Course.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show Cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

1. University/Affiliating body NOC not submitted.
2. In Online Application Form, Transaction Id No. 45114772 is mentioned but Challan/Fee-receipt not submitted.
3. Photocopy of Land Document submitted but certified copy not submitted.
4. Photocopy of Building plan submitted but Blue Print/notarized copy not submitted.
5. In Building Plan, Built-up Area is less as per norms for proposed B.Ed. & D.El.Ed. Courses.
6. Notarized copy of Building Completion Certificate not submitted.
7. Photocopy of CLU submitted but Notarized Copy of CLU not submitted.
8. Notarized copy of Non-Encumbrance Certificate not submitted.
9. FDRs not submitted as per NCTE norms.

AND WHEREAS, the Show Cause Notice was issued to the institution on **10.02.2016** and the reply was received on **12.02.2016**.

AND WHEREAS, the matter was placed before the WRC in its 248th Meeting held on April 11-12, 2016, the committee observed that:- "...The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."

AND WHEREAS, the inspection letter was sent to the institution on **15.04.2016** and the inspection conducted of the institution on **25.04.2016** and VTR received in office on **26.04.2016**.

AND WHEREAS, VTR was placed in **250th Meeting held on April 27-28, 2016** of WRC and the Committee decided that "...The two cases APP2942 and APP2964 were taken together. VT visited the institution on 25/04/2016. VT report was perused and CD was viewed.

The institution has the required infrastructural and instructional facilities. The VT has recommended the case.

Hence, LOI be issued for one unit of the B.Ed. course and one unit of the D.El.Ed. course.

The Applicant be informed that the case will be considered for the session 2016-2017, only if the formalities necessary after issue of LOI are completed well before 2nd May, 2016."

AND WHEREAS, the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on **30.04.2016** and the reply received on **29.04.2016**.

AND WHEREAS, the reply was placed in 254th Meeting held on June 7-9, 2016 of WRC and the Committee decided that "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal and 10 faculty members, who are qualified and approved by the affiliating body.

Hence, Recognition is granted for one unit of 50 students for the B.Ed. course from the academic session 2017-2018."

AND WHEREAS, the Recognition order was issued to the institution on 20.06.2016.

AND WHEREAS, as directed by WRC, in its 253rd Meeting held on may 24-26, 2016, it was decided that: "The WRC while granting recognition for 2016-17 noticed that the institutions submitted the staff profile approved by the affiliating body within a short period of issue of the letter of intent. WRC, has, therefore, decided that in all cases in which recognition has been given for the academic session 2016-2017, a copy of the staff list submitted by the institution be sent to the concerned affiliating body to verify the signature and seal of the approving authority giving 30 days time. Similarly, a copy of the CLU(s), copy of the Minority Certificate in case of Minority institutions and a copy of the NOC of the affiliating body be sent to the Issuing Authorities for authentication giving 30 days time.

The cases after expiry of a period of 30 days may be placed before the WRC for consideration and decision."

AND WHEREAS, letter was sent to the Registrar, Vikram University on 14.07.2016 regarding verification of the staff profile but reply not received till date.

AND WHEREAS, letter was sent to the SDO (Revenue), Agar, Madhya Pradesh, on 14.07.2016 regarding verification of CLU but reply not received till date.

AND WHEREAS, letter was sent to the Registrar, Vikram University on 14.07.2016 regarding verification of NOC and the reply received on 02.09.2016.

AND WHEREAS, the matter was placed in 261st Meeting held on October 26-28, 2016 of WRC and the Committee decided that "...The copy of the NOC was submitted to the affiliating body on 14/07/2016. Vide reply received on 02/09/2016 Vikram Vishwavidhyalaya has confirmed that the NOC was not issued by the University.

Hence, Show Cause Notice be issued to the institution on the above ground.

The replies to other verification letters are awaited."

AND WHEREAS, the Show Cause Notice was issued to the institution on 02.11.2016 and the reply was received on 20.12.2016.

AND WHEREAS, the matter was placed in 283rd Meeting held on November 14-15, 2017 of WRC and the Committee decided that "...The case pertains to issue of NOC from Vikram University, The Registrar, Vikram University vide letter dated 19.08.2016 has informed that it has not issued NOC No.3165 dated 29.05.2015. However, it has issued NOC No.1513 dated 13.05.2016.

Show Cause Notice dated 02.11.2016 was issued to the institution in this regard. The institution had replied on 20.12.2016. It has not offered any valid explanation for this discrepancy.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs, if any, be returned.

Simultaneously, Show Cause Notice be issued to the institution for D.Ed. course (APP2942) as to why the recognition should not be withdrawn since now the college is a standalone institution."

NOW, THEREFORE, the recognition granted **BUDDHISAGAR COLLEGE, PLOT NO: 979, 982, 983, VILLAGE: JAMLI, POST OFFICE: BADOD, TEHSIL: BADOD, CITY: AGAR- MALWA, DISTRICT: SHAJAPUR- 465441, MADHYA PRADESH** for conducting B.Ed. course vide order dated **20.06.2016** is hereby withdrawn from the academic session 2018-2019, under section 17/(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing of appeal may be seen on NCTE website.
