REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, GROUP INSTITUTION SOCIETY, PLOT NO- 198, STREET-PATHARIYA JAT, VILLAGE- PATHARIYA JAT, POST OFFICE- BIKA BAMHORI, TEHSIL- SAGAR, CITY- SAGAR, DISTRICT: SAGAR- 470228, MADHYA PRADESH had submitted the online application on 24.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to A R M COLLEGE, PLOT/KHASRA NO: 304, STREET- SIRONJA, NARSINGHPUR ROAD, VILLAGE- SIRONJA, POST OFFICE- BIKA BAMHORI, TEHSIL-SAGAR, CITY- SAGAR, DISTRICT: SAGAR- 470228, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 07.08.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, the WRC in its 241st meeting held on February 04-06, 2016 it was decide as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

Hence, in view of the above, Show Cause Notice is issued on the following points:-

1. Photocopy of Land Document submitted but certified copy not submitted.
2. In Land documents & CLU, Society Name does not match with Online Application Form.
3. Photocopy of Building Plan submitted but Blue Print/Notarized copy not submitted.
4. Notarized copy of Building Completion Certificate not submitted.
5. Photocopy of CLU submitted but notarized copy not submitted.
6. Notarized copy of Non- Encumbrance Certificate not submitted.
7. FDRs not submitted as per NCTE norms.

AND WHEREAS, the Show Cause Notice was issued to the institution on 12.02.2016 and the reply received on 08.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 254th Meeting held on June 7-9 2016 and the Committee observed that "...Show Cause Notice was issued on 12/02/2016 and the reply was received on 08/03/2016. While the institution has submitted most of the documents as stated in Show Cause Notice, the certified copy of land document and the CLU are still in the name of Group India Society. This should be got corrected in the name of Group Institution Society.

As soon these documents are received, the case will be processed further.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, the Clarification letter was issued to the institution on 10.06.2016 and the reply received on 28.07.2016.

AND WHEREAS, the reply was placed before the WRC in its 262nd Meeting held on November 10-11, 2016 and the Committee observed that "...The Clarification letter was sent to the institution on 10.06.2016 regarding Certified Copy of Land documents and CLU which are still in the name of Group India Society.

The institute replied on 28.07.2016. It is seen that the institute has not changed the Name of the Society 'Group India Society' to 'Group Institution Society', Sagar.

The institution should comply with the essential documents for both the B.Ed. and D.El.Ed. courses (APP2237)."

AND WHEREAS, the Compliance letter was issued to the institution on 23.11.2016 and the reply received on 23.12.2016.

AND WHEREAS, the reply was placed before the WRC in its 272nd Meeting held on April 6-8, 2017 and the Committee observed that "...Compliance letter was sent to the institution 23/11/2016 asking for submission of essential documents for both B.Ed. and D.El.Ed. courses.

From the reply of the institution it is clear that the case is under process by the Revenue Authorities.

Since, this case has been pending for a long time, the institution should submit the required documents within 1 month.

Hence, Show Cause Notice be issued as to why the Recognition should not be refused on the above ground."

AND WHEREAS, the Show Cause Notice was issued to the institution on **11.04.2017** and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 283rd Meeting held on November 14-15, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 11.04.2017. The institution has not replied to the Show Cause Notice till date.

Hence, Recognition is refused."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **A R M COLLEGE, PLOT/KHASRA NO: 304, STREET- SIRONJA, NARSINGHPUR ROAD, VILLAGE- SIRONJA, POST OFFICE- BIKA BAMHORI, TEHSIL-SAGAR, CITY- SAGAR, DISTRICT: SAGAR- 470228, MADHYA PRADESH** for B.ED. Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1; Bahadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode, using website www.ncte-india.org.
