REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHRI BANSHRAJ SINGH SIKSHA SAMITI BAGHAI RAMPUR, PLOT NO- 743/1/KH/2, STREET NO- 03, VILLAGE- RAMPUR BAGHELAN, POST OFFICE- RAMPUR BAGHELAN, TEHSIL-RAMPUR BAGHELAN, CITY- RAMPUR BAGHELAN, DISTRICT: SATNA- 485115, MADHYA PRADESH had submitted the online application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to BANKE BIHARI SINGH COLLEGE OF EDUCATION, PLOT/KHASRA NO-743/1/KH/2 & 743/1/KH/1, STREET NO- 03, VILLAGE- RAMPUR BAGHELAN, POST OFFICE- RAMPUR BAGHELAN, TEHSIL-RAMPUR BAGHELAN, CITY- RAMPUR BAGHELAN, DISTRICT: SATNA- 485115, MADHYA PRADESH for starting the B.E.D. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- 1. Photocopy of Land Document submitted but certified copy not submitted.
- 2. Name of institution /Society does not match with Online Application Form in NOC of University/Affiliating Body.
- 3. Serial No. 05 not fill, Society name is incomplete and Intake not mentioned in the Affidavit.
- 4. Blue Print/ Notarized copy of Building Plan not submitted, only photocopy submitted and not approved by any competent authority and Khasra No., Land Area & Built-up area not readable.
- 5. Noarized Copy of Building Completion Certificate not submitted.
- 6. Notarized copy of CLU not submitted.
- 7. Notarized copy of Non-Encumbrance Certificate not submitted.
- 8. FDRs not submitted as per NCTE norms.
- 9. In online Application Form, Existing/Applied course not mentioned but as per our record and as also mentioned at covering letter of Online Application., the institution is applied for D.El.Ed. Course- (APP3085)

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.02.2016 and the reply was received on 22.03.2017.

AND WHEREAS, the reply was placed before the WRC in its 262nd Meeting held on November 10-11, 2016, the committee observed that: "...It has been informed by the RD that vide WRO letter dated 28.10.2015, the institution was asked to submit the duplicate Application file alongwith DD for the D.El.Ed. Course (APP3085).

The Case be put after D.El.Ed. Course (APP3085) file is received."

AND WHEREAS, a letter was issued to the institution on 17.11.2016 and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 279th Meeting held on August 10-11, 2017 and the Committee observed that "...The WRO vide letter dt. 17.11.2016 informed that the institute needs to submit the duplicate file for the D.El.Ed. course (APP3085). The institute has not replied to till date.

Hence, Recognition is refused for the B.Ed. course.
