Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Bharat Utkarsh Sewa Sansthan, Plot No. - 1324/4, Street/Road - Naila Road Sarkhon Janjgir, Village - Sarkhon, Post Office - Janjgir, District - Janjgir-Champa, Chhattisgarh-495668 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Utkarsh College of Education, Plot No. - 1324/4, Street No. - Naila Road, Village - Sarkhon, Post Office/Tehsil - Janjgir, District - Janjgir-Champa, Chhattisgarh-495668 for conducting M.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply of Show Cause Notice was not submitted by the institution and institution vide letter dt. 04.03.2016 received in this office on dt. 22.03.2016 has requested to WRC for the withdrawal of application.

And whereas, the matter was placed before the WRC in its 261st meeting held on 26th-28th October, 2016 and Committee decided to issue Clarification letter to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 13/02/2016 and no reply has been received till date.

In the meanwhile, the institution vide letter dt. 04/03/2016, has requested for withdrawal of the application. For this a resolution from the management is required.

Hence, Clarification be obtained on the above grounds. The reply should be submitted within 30 days."

Accordingly Clarification letter was issued to the institution on dt. 03.11.2016 and reply of Clarification letter was not submitted by the institution.

And whereas, the matter was placed before the WRC in its 271st meeting held on 23rd-25th March, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Letter was issued to the institution on 03.11.2016 regarding resolution of the management for closure of the course. Reply has not been received till date.

Hence, Recognition is refused u/s 15(3)(b) of NCTE Act, 1993. FDRs be returned, if any."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to B.Ed. course to Utkarsh College of Education, Plot No. - 1324/4, Street No. - Naila Road, Village - Sarkhon, Post Office/Tehsil - Janjgir, District - Janjgir-Champa, Chhattisgarh-495668.**


