Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Sarvada Srijan Shikshan Aum Seva Sansthan, Plot No. 1060/22, Street/Road - 1061, 1062, 1063/1, Villagae - Loharsingh, Post Office - Kondatarai, Tehsil/Taluka - Pusaur, District - Raigarh, Chhattisgarh-496100 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Maa Mangala College, Plot/Khasra No. - 1060/2, 1061/2, 2, Street No. - Sarangarh, Village - Loharsingh, Post Office - Kondatarai, Tehsil/Taluka - Pusaur, District - Raigarh, Chhattisgarh-496100 for conducting B.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply was submitted by the institution on 09.03.2016.

And whereas, the reply of SCN was placed in 248th meeting held on 11th-12th April, 2016 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 30.04.2016.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 261st meeting of WRC held on 26th-28th October, 2016 and Committee decided to issue Clarification letter on following points:-

"The case file was seen. The VT Report was received in the WRO on 22/04/2016 and the VT has mentioned that the President of the institution submitted a letter dt. 18/04/2016 to the VT Team for handing it over to the RD, WRO.

The management of the institution has requested the WRO not to process their application for the B.Ed. course (APP3112).

The management be asked to send a resolution to this effect.

Hence, Clarification be obtained on the above grounds. The reply should be submitted within 30 days."

Accordingly Clarification letter was issued to the institution on dt. 03.11.2016 and reply of Clarification letter was not submitted by the institution.

And whereas, the matter was placed before the WRC in its 271st meeting held on 23rd-25th March, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Clarification letter was issued to the institution on 03.11.2016 regarding submission of resolution for their application for closure of B.Ed. course. Till date the reply has not been received.

Hence, Recognition is refused u/s 15(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to B.Ed. course to Maa Mangala College, Plot/Khasra No. - 1060/2, 1061/2, 2, Street No. - Sarangarh, Village - Loharsingh, Post Office - Kondatarai, Tehsil/Taluka - Pusaur, District - Raigarh, Chhattisgarh-496100.**
