Refusal Order

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was not submitted by the institution.

And whereas, the matter was placed in 247th meeting held on 04 - 06th April, 2016 and the Committee decided to refuse recognition to the institution on the following points:-

"The institution is running the B.Ed. with two units and has now applied for the B.A.B.Ed./B.Sc. B.Ed. course. Show Cause Notice was issued to the institution on 09/02/2016. Reply has not yet been received.

Hence, Recognition is refused. FDRs if any, be returned."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, the Western Regional Committee hereby refuses recognition to Shree V H Patel College of Education (Integrated) Dharampur, Plot/Khasara No. 255/1, village/Post office - Karanjaveri, Tehsil/Taluka -Dharampur, District - Valsad - 396050, Gujarat for B.A./B.Sc. B.Ed. 04 years Integrated course.
