Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Sai Shanti Shikshan Samiti, Plot No. 287/2, Street/Road – PH-30, Village – Deurjhal, Post Office – Ahiwara, Tehsil/Taluka – Durg, District – Durg, Chhattisgarh-490036 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Shri Sai D.Ed. College, Plot/Khasra No. – 287/2, Street No. – PH-30, Village – Deourjhal, Post Office – Ahiwara, District – Durg, Chhattisgarh-490036 for conducting B.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 19.02.2016, and reply was submitted by the institution on 21.03.2016.

And whereas, the reply of SCN was placed in 248th meeting held on 11th-12th April, 2016 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 07.05.2016.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 261st meeting of WRC held on 26th-28th October, 2016 and Committee decided to issue Clarification on following points:-

"The case file was seen. The VT visited the institution on 07/05/2016. The CD was seen and VTR perused. The CD shows a building with infrastructural and instructional facilities.

The VT has mentioned that the built up area is only 2670 sq. mtrs. and the building was incomplete and construction work is going on. The VT also mentions that there were no rooms for method class, staff room etc.

Before the case can be processed further, the institution is required to submit proof with documentary evidence that all the required rooms are in place and complete as per NCTE requirement. It should also submit the latest Building Completion Certificate issued by the competent authority.

Hence, Clarification be obtained on the above grounds. The reply should be submitted within 30 days."

Accordingly Clarification letter was issued to the institution on dt. 03.11.2016 and reply of Clarification was submitted by the institution on dt. 05.12.2016.

And whereas, the matter was placed before the WRC in its 264th meeting held on 14th-15th December, 2016 and Committee decided to issue letter of Conveying Decision to the institution on the following points:-

"The case file was seen. The WRC in its 261st meeting had recorded that as per VT Report, the building was incomplete, and construction work was going on. Further, there were no rooms for method class, staff room etc. The VT had also mentioned that the built up area is only 2670 sq. mtrs.

In response to the Clarification letter, the institution has submitted a Building Plan approved by the Town & Country Planning, Durg and the Building Completion Certificate issued by the Sarpanch, Gram Panchayat, Potiya. However, the Building Completion Certificate is not counter signed by a Rural Govt. Engineer.

Since, structural changes are involved, a VT needs to be reconstituted. The institution is required to submit a sum of Rs. 1.50 lakhs for reconstitution of VT."

Accordingly Conveying Decision letter was issued to the institution on dt. 20.12.2016 and reply of letter of Conveying Decision was not submitted by the institution.

And whereas, the matter was placed before the WRC in its 271st meeting held on 23rd-25th March, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. A letter was written to the institution for submission of Rs.1.50 lakhs towards inspection fee. The institution has not submitted any reply till date.

Hence, Recognition is refused u/s 15(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refused grant of recognition to D.El.Ed. course to Shri Sai D.Ed. College, Plot/Khasra No. - 287/2, Street No. - PH-30, Village - Deourjhal, Post Office - Ahiwara, District - Durg, Chhattisgarh-490036.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
