**Refusal Order**

Whereas in terms of section 15 of the NCTE Act, 1993, Bhagirathi Shiksha and Seva Samiti, Street/Road – Street No. L-5, Village – Mishra Bhawan Vinobanagar, District – Bilaspur, Chhattisgarh - 495001 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Lal Bahadur Shastri Shiksha Mahavidyalaya, Plot/Khasra No. 2651/2, 2651/3, Village – Baloda, Tehsil/Taluka – Baloda, District – Janjgir-Champa, Chhattisgarh-495559 for conducting M.Ed. course.

And whereas, the proposal was examined by WRC in its 241<sup>st</sup> meeting held on 4<sup>th</sup>-6<sup>th</sup> February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply was submitted by the institution on 17.03.2016.

And whereas, the reply of SCN was placed in 248<sup>th</sup> meeting held on 11<sup>th</sup>-12<sup>th</sup> April, 2016 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 30.04.2016.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 261<sup>st</sup> meeting of WRC held on 26<sup>th</sup>-28<sup>th</sup> October, 2016 and Committee decided to issue Clarification on following points:-

*"The case file was seen. The VT visited the institution on 30/04/2016. The CD was seen and VTR perused. The CD shows a good building with good infrastructural and instructional facilities.*

*The institution should inform the latest position regarding NAAC Certification failing which this case will not be processed further.*

**Hence, Clarification be obtained on the above ground. The reply should be submitted within 30 days."**

Accordingly clarification letter was issued to the institution on dt. 03.11.2016.

And whereas, reply of clarification dt. 23.11.2016 received in this office on 05.12.2016, was placed before the WRC in its 264<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> December, 2016 and Committee decided to issue Show Cause Notice to the institution on following points:-

*"The case file was seen. Clarification letter was issued to the institution on 03/11/2016 regarding the requirement of NAAC certification as per NCTE Regulations, 2014.*

*The institution has not provided satisfactory answer in this regard. Further, the institution does not have the required land for running the 3 courses of B.Ed., D.Ed. and M.Ed. courses. Since, the institution is already running B.Ed. and D.Ed. courses, it does not have the land for the running the M.Ed. course.*

**Hence, Show Cause Notice be issued on the above grounds."**

Accordingly Show Cause Notice was issued to the institution on dt. 20.12.2016.

And whereas, reply of clarification dt. 17.02.2017 received in this office on 17.02.2017, was placed before the WRC in its 269<sup>th</sup> meeting held on 20<sup>th</sup>-22<sup>nd</sup> February, 2017 and Committee decided to issue Refusal Order to the institution on following points:-

"The case file was seen. Show Cause Notice was issued to the institution regarding the submission of NAAC certificate. The institution has not submitted any document other than the one which was submitted on 29/05/2015.

**Hence, Recognition is refused."**

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to , M.Ed. course to Kanti Darshan Shaikshanik and Computer Training Institute, Plot/Khasra Number - 24/2-3, Village - Kosa Nagar, Post Office - Nehru Nagar, Tehsil/Taluka - Durg, District - Durg, Chhattisgarh - 490020.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
