#### Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Drona Education College, Plot/Khasra No. – 787/2, Village – Sakri, Post Office – Sakri, Tehsil/Taluka – Takhatpur, District – Bilaspur, Chhattisgarh - 495001 had submitted the application on 30.06.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting D.El.Ed. Course.

And whereas, the proposal was examined and the Show Cause Notice letter was issued to the institution on 11.02.2016, and reply was submitted by the institution on dt. 03.03.2016.

And whereas, the matter was placed in 247<sup>th</sup> meeting held on 4<sup>th</sup> - 6<sup>th</sup> April, 2016 and Committee decided to issue Clarification to the institution on the following points:-

"The case file was seen. The institution is running only the D.El.Ed. course which makes it a standalone institution which not permitted under clause 2(b) of the NCTE Regulations, 2014. The institution has not submitted any proof of running other courses.

Show Cause Notice was issued to the institution on 11/02/2016 and reply was received on 03/03/2016.

The institution has satisfactorily addressed the points of Show Cause Notice except for the submission of notarized copy of the CLU and Non-Encumbrance Certificate.

### Hence, Clarification be obtained on the above grounds."

Accordingly, Clarification letter was issued to the institution on 09.04.2016.

And whereas, institution has not submitted the reply of Clarification letter dt. 09.04.2016 to till date and matter was placed before the WRC in its  $266^{th}$  meeting of WRC held on January  $10^{th}$  –  $12^{th}$ , 2017 and Committee decided to issue refusal order to the institution on following points:

"The case file was seen. Clarification letter/Show Cause Notice dt. 09/04/2016 was issued to the institution. Reply has not been received till date.

### Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to the Drona Education College, Plot/Khasra No. – 787/2, Village – Sakri, Post Office – Sakri, Tehsil/Taluka – Takhatpur, District – Bilaspur, Chhattisgarh - 495001.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 <a href="www.ncte-india.org">www.ncte-india.org</a> to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
