REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **Veena Vadini Samaj Kalayan Vikas Samiti, Plot no.: HS2, Street/Road: Anand Nagar Bahodapur, Vill.: Gwalior, P.O.: Bahodapur, Teh./Tal.: Gwalior, Town/City: Gwalior, Dist.: Gwalior - 474012, Madhya Pradesh (WRCAPP3217)** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Veena Vadini Teachers Training Institute, Plot/Khasra No. 1056, 1057, Plot no.: HS2, Street/Road: Anand Nagar, Vill.: Gwalior, P.O.: Bahodapur, Teh./Tal.: Gwalior, Town/City: Gwalior, Dist.: Gwalior - 474012, Madhya Pradesh** for **B.A.B.Ed./B.Sc.B.Ed. 4 years integrated course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 15.07.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before the WRC in its 237th meeting of the WRC held on December 21-22, 2015 and the Committee decided that "...The applicant has sufficient land area and built up area for two units of B.Ed. and one unit each of D.Ed. and M.Ed., and the proposed integrated course. **Hence, VT be constituted.**

RD/WRO should obtain the following documents:-

- (i) Duly notarized copies of approved building plan, CLU, building completion certificate, Certificate of registration of Society, bye-laws, memorandum of association; and
- (ii) FDRs not submitted as per NCTE Regulations, 2014.

The Department of Higher Education, Govt. of M.P. has recommended the case.

The applicant has applied for an integrated course, it is not clear whether it is B.A. B.Ed. or B.Sc. B.Ed. The Society be asked to clarify whether it is applying for B.Sc. B.Ed. Or for B.A. B.Ed."

AND WHEREAS, the Visiting Team visited the institution on 18.01.2016. Institution has refused the inspection.

AND WHEREAS, the visiting team has informed that the institution has requested to defer the inspection. Institution also vide letter dt. 16.01.2016 has requested to defer the inspection till the next session were placed before WRC in its 242nd meeting held on

February 11-13, 2016. The Committee decided that "...The institute is already running the B.Ed. D.Ed. and M.Ed. courses and it has applied for B.Ed. part time course, B.Ed.M.Ed. integrated course and B.A.B.Ed./B.Sc.B.Ed. integrated course. This case relates to the last stated course. The VT went for inspection on 18/01/2016 but the institute refused the inspection.

The institute be asked to deposit a fee of Rs.1.5 lakhs after which the VT will be reconstituted. The should also clarify if it wants the B.A.B.Ed./ or the B.Sc.B.Ed.course."

AND WHEREAS, the Clarification letter was issued on 18.02.2016.

AND WHEREAS, the reply dt. 02.04.2016 & 04.04.2016 of the Institution were placed before WRC in its 247th meeting held on April 04-06, 2016. The Committee decided that "...The institution was issued a clarification letter on 18/02/2016 to submit a fee of Rs. 1.50 lakhs for inspection of the B.A.B.Ed./B.Sc.B.Ed. course. The institution vide letter dt. 19/01/2016 has requested to defer the inspection till the next session. **The case be put up as and when the institution submits the fee of Rs. 1.50 lakhs."**

AND WHEREAS, the Clarification letter was issued on 20.04.2016.

AND WHEREAS, the reply dt. 27.04.2016 of the Institution were placed before WRC in its 261th meeting held on October 26-28, 2016. The Committee decided that "...Clarification letter was issued to the institution 20/04/2016 and the institution replied on 27/04/2016.


The institution has requested that the fee of Rs. 1.50 Lakhs may be waived. As per records, VT was constituted and VT was sent to the institution and the institution refused inspection. To constitute another a fee of Rs. 1.50 Lakhs has to be paid and no exemption can be made in this regard.

Response to this should be submitted within one month failing which further necessary action could be taken."

AND WHEREAS, the letter was issued on 02.11.2016, Reply not submitted by institution.

AND WHEREAS, the matter of reply not received was placed before WRC in its 278th meeting held on July 25-26, 2017. The Committee decided that "...The institute was informed through a show cause notice on 02.11.2016 that for another VT, a fee of Rs. 1.5 lakhs has to be paid. The institute has not replied till date. **Hence, Recognition is refused. FDRs, if any, be returned."**

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses recognition/permission to **Veena Vadini Teachers Training Institute, Plot/Khasra No. 1056, 1057, Plot no.: HS2, Street/Road: Anand Nagar, Vill.: Gwalior, P.O.: Bahodapur, Teh./Tal.: Gwalior, Town/City: Gwalior, Dist.: Gwalior - 474012, Madhya Pradesh** for the **B.A.B.Ed./B.Sc.B.Ed. 4 - Years** integrated programme.
