Refusal Order

Whereas in terms of Section 14 of the NCTE Act, 1993, Shri Guru Baal Utthan Samiti, Plot no. 175/1, Street/Road- Bilaspur Road, Village- Ranisagar, Post office- Kota, Tehsil/Taluka- Kota, District- Bilaspur, Chhattisgarh- 495113 had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Global College, Plot no. 175/1, Street no. - Muharkhar, Village- Ranisagar, Post office- Kota, Tehsil/Taluka- Kota, District- Bilaspur, Chhattisgarh- 495113 for B.Ed. 02 years course for the academic session 2016-2017.

And whereas, the proposal was examined and the Show Cause Notice was issued to the institution on 10.02.2016, and reply was not submitted by the institution.

And whereas, the matter was placed in 247th meeting held on 04 - 06th April, 2016 and the Committee decided to refuse recognition to the institution on the following points:-

"Show Cause Notice was issued to the institution on 10/02/2016. Till date no reply has been received.

Hence, Recognition is refused. FDRs if any, be returned."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of the NCTE Act, 1993, **the Western Regional Committee hereby refuses recognition to Global College, Plot no. 175/1, Street no. - Muharkhar, Village- Ranisagar, Post office- Kota, Tehsil/Taluka- Kota, District- Bilaspur, Chhattisgarh- 495113 for B.Ed. 02 years course.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
