REFUSAL ORDER

Date: **16 Aug 17**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, TAKSHSHILA SHIKSHA EVAM JANKALYAN SAMITI, RACHNA NAGAR, DISTRICT: BHOPAL- 462036, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to TAKSHSHILA COLLEGE, PLOT/ KHASRA NO- 430/2/2, 430/2/3, STREET NO: NH- 12, VILLAGE- JHIRNIYA, PGST OFFICE-MUGALIYA HAAT, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462036, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 05.09.2015 requesting to give their recommendation/comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-
"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

1. Address mentioned in Society Registration Certificate & Bye-laws does not match with online application form.
2. Address not mentioned in NOC of University / Affiliating body.
3. Photocopy of Building Plan submitted but Blue Print/ Notarized copy not submitted.
4. Photocopy of Building Completion Certificate submitted but notarized copy not submitted.
5. In Building Plan & Building Completion Certificate, Bilt-UP Area is less, as per norms.
6. Photocopy of CLU's submitted but notarized copy not submitted.
7. FDRs not submitted, as per NCTE norms.

AND WHEREAS, the Show Cause Notice was issued to the institution on 13.02.2016 and the reply was received on 02.04.2016.

AND WHEREAS, the reply was placed before the WRC in its 248th Meeting held on April 11-12, 2016, the committee observed that:- "...The Committee also reviewed the status of the applications received for the academic session 2016-2017 and found that a number of applications where Show Cause Notices were issued and reply received are to be considered. In order to expedite the processing of such cases, the Committee decided that the RD, WRO should constitute VT in such cases where the institution has submitted reply/documents as per the requirements laid down in the NCTE Regulations, 2014 and in the Norms and Standards for that particular course. The case be put up before the WRC on receipt of the VTR."

AND WHEREAS, the RD WRO constituted the visiting team.

AND WHEREAS, the inspection letter issued to the institution on 23.04.2016 and the inspection conducted of the institution on 01.05.2016.

AND WHEREAS, the VTR was placed before the WRC in its 260th Meeting held on October 13-15, 2016 and the Committee observed that "...The VT visited the institution on 01/05/2016. The CD was seen and VTR perused. The CD shows a building with adequate infrastructural and instructional facilities. The VT has recommended the case.

However, on scrutiny it is found that the size of the multipurpose hall is 160 sq. mtrs. which is less than the NCTE requirement of 2000 sq. ft.

Hence, Show Cause Notice be issued on the above ground."

AND WHEREAS, the Show Cause Notice was issued to the institution on 19.10.2016 and the reply was received on 07.11.2016.

AND WHEREAS, the reply was placed before the WRC in its 264th Meeting held on December 14-15, 2016 and the Committee observed that "...Show Cause Notice was issued to the institution on 19.10.2016 regarding the size of the multipurpose hall. The institute vide reply dt. 07.11.2016 has submitted an approved Building Plan, wherein, it is seen that the multipurpose hall is 2010.4 sq mtrs. Since there is structural change, VT needs to be reconstituted.

The institute is required to submit a fee of Rs. 1.50 lakhs to reconstitute the VT."

AND WHEREAS, a letter was issued to the institution on **19.12.2016** and the institution has not submitted the reply till date.

AND WHEREAS, the matter was placed before the WRC in its 279th Meeting held on August 10-11, 2017 and the Committee observed that "...The WRO vide letter dt. 19.12.2016 informed that the institute needs to submit a fee of Rs. 1.5 lakhs to reconstitute re VT. The institute has not replied to till date.

Hence, Recognition is refused.
FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **TAKSHSHILA COLLEGE, PLOT/ KHASRA NO- 430/2/2, 430/2/3, STREET NO: NH- 12, VILLAGE- JHIRNIYA, POST OFFICE-MUGALIYA HAAT, TEHSIL- HUZUR, CITY- BHOPAL, DISTRICT: BHOPAL- 462036, MADHYA PRADESH** for **B.ED. Course**.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
