Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Jagrani Devi Moddle Convent School Shikshan Samiti, Plot Number – 430/2, Street/Road –Main Road Jaijaipur, Village – Darrabhatha, Post Office-Thathari, Tehsil/Taluka – Jaijaipur, District – janjgir-Champa, Chhattisgarh – 495690, had Submitted the application on 30.06.2015 to the Western Regional Committee, NCTE for grant of recognition to Jagrani Devi College Of Education, Plot No. -430/2, Street No.- 1/1, Village- Darrabhatha, Post Office- Thathari, Tehsil/Taluka- Jaijaipur, District-Janjgir-Champa, Chhattisgarh- 495690 for conducting D.El.Ed. Course.

And whereas, the proposal was examined by WRC in its 241^{st} meeting held on 4^{th} - 6^{th} February, 2016 and the Show Cause Notice letter was issued to the institution on 11.02.2016, and reply was submitted by the institution on dt. 10.03.2016.

And whereas, the matter was placed in 266^{th} meeting held on 10^{th} – 12^{th} January, 2017 and Committee decided to issue letter of Clarification to the institution on the following points:

"The case file was seen. Show Cause Notice was issued to the institution on 11/02/2016 and reply was received on 10/03/2016. The institution is running the B.Ed. course with 2 units and now it has applied for D.El.Ed. course (APP2704) and M.Ed. (APP3369).

All the land documents of the above are in the name of JAGRANI DEVI COLLEGE OF EDUCATION, at Khasra NO. 539/2 in Village- Baradwar.

The Society has also applied for a B.Ed. course(APP3374) and a D.El.Ed. course (APP3312) both at JAGRANI DEVI COLLEGE OF EDUCATION, at PLOT NO. 430/2 in Village – Darrabhatha.

An examination of the files shows the following deficiencies:-

- a) All the land documents are in the name of an individual namely Brijbhushan Dwivedi.
- b) The CLU together with the latest premium receipt has not been submitted.
- c) Building Plan approved by the competent authority has not been submitted.

Compliance in this matter should be submitted within 30 days."

And whereas, accordingly letter of Clarification was issued to the institution on 17.01.2017, and reply was submitted by the institution on dt. 08.02.2017.

And whereas, the matter was placed before the WRC in its 271^{st} meeting held on 23^{rd} – 25^{th} March, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued followed by a clarification letter on the ground that the land is in the name of an individual. The land has to be transferred either through sale or gift deed etc. and the same should be registered in the office of the Sub-Registrar. Since enough opportunity was given to the Society to effect this change, the Society has not complied with the essential requirement.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refused grant of recognition to D.El.Ed. course to the Jagrani Devi College Of Education, Plot No. -430/2, Street No.- 1/1, Village-Darrabhatha, Post Office- Thathari, Tehsil/Taluka- Jaijaipur, District- Janjgir-Champa, Chhattisgarh- 495690.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
