**REFUSAL ORDER**

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, SHREE BRAHMANAND SARASWATI SHIKSHA SAMITI, PLOT NO- 550/14, STREET- SBI CHOWK, CITY- JABALPUR, POST OFFICE- VIJAY NAGAR, TEHSIL- JABALPUR, DISTRICT: JABALPUR- 482003, MADHYA PRADESH had submitted the online application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to SHREE BRAHMANAND SARASWATI COLLEGE OF EDUCATION, PLOT/ KHASRA NO- 137, 138, 139, STREET NO- 41/65, VILLAGE- BASHA, POST OFFICE- GARHA MAIN, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT: JABALPUR- 482003, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241<sup>st</sup> Meeting of the WRC held on February, 04-06, 2016, it was decided as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order issue Show cause Notice to the rest..."

AND WHEREAS, Show Cause Notice was issued to the institution on the following points:-

- Affidavit on Rs. 100/- in the prescribed Proforma not submitted.
- Certified copy registered land documents issued by the competent authority as required under provision of section 8 (4) (i) of NCTE Regulations, 2014, not submitted.
- Blue Print/Notarized copy of Building Plan issued by competent authority not submitted.
- Notarized copy of Building Completion Certificate issued by competent authority not submitted.(submitted photocopy)
- A notarized copy of Change of land use (CLU) certificate not submitted. (submitted photocopy)
- Notarized copy of Non-Encumbrance Certificate issued by competent authority not submitted. (submitted photocopy)
- FDRs as per NCTE Regulations, 2014 not submitted.

AND WHEREAS, the Show Cause Notice was issued to the institution on 15.02.2016 and the reply of Show Cause Notice was received on 22.02.2016.

AND WHEREAS, the matter was placed before WRC in its 253<sup>rd</sup> Meeting held on May 24-26 2016 and the Committee decided that "...Show Cause Notice was issued to the institution on 15/02/2016 and the reply was received on 22/02/2016. The institution has submitted all the required documents except for originally certified copy of the land documents from the Sub-Registrar.

Hence, Clarification be obtained on the above ground."

AND WHEREAS, the Clarification letter was issued to the institution on 30.05.2016 and the reply of Clarification letter was received on 22.02.2016.

AND WHEREAS, the reply was placed before WRC in its 262<sup>nd</sup> Meeting held on November 10-11, 2016 and the Committee decided that "...The Clarification letter was sent to the institution on 30.05.2016. The institute has submitted originally Certified Land documents from the Sub Registrar, Jabalpur.

On perusal of file, it is seen that the NOC issued by the Affiliating Body is for B.Sc.B.Ed. course and not for B.Ed. course. Show Cause Notice be issued on this point. The reply be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 21.11.2016 and the reply of Show Cause Notice was received on 20.12.2016.

AND WHEREAS, the reply was placed before WRC in its 272<sup>nd</sup> Meeting held on April 6-8, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 21/11/2016.

**The institution has not given satisfactory answer. Hence, Recognition is refused."**

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **SHREE BRAHMANAND SARASWATI COLLEGE OF EDUCATION, PLOT/ KHASRA NO- 137, 138, 139, STREET NO- 41/65, VILLAGE- BASHA, POST OFFICE- GARHA MAIN, TEHSIL- JABALPUR, CITY- JABALPUR, DISTRICT: JABALPUR- 482003, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website [www.ncte-india.org](http://www.ncte-india.org).
