REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **TIMES COMPUTER EDUCATION SOCIETY, PLOT NO- 19, STREET- DAMOH, VILLAGE- GWARI, POST OFFICE- DAMOH, TEHSIL- DAMOH, CITY- DAMOH, DISTRICT: DAMOH- 470661, MADHYA PRADESH** had submitted the online application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition to **TIMES COLLEGE, KHASRA NO- 102, 111, PLOT NO- 19, VILLAGE- GWARI, POST OFFICE- DAMOH, TEHSIL- DAMOH, CITY- DAMOH, DISTRICT: DAMOH- 470661, MADHYA PRADESH** for starting the **B.ED.** Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the matter was placed before WRC in its **242<sup>nd</sup> Meeting held on February 11-13, 2016** and the Committee decided that "...The institute has applied for the B.Ed. course. It is also running a D.Ed. course and has also applied for a D.El.Ed. course.

An examination of the documents shows that the NOC from the affiliating body has not been submitted. It is also noticed that the land is in the name of an individual which is not permitted under clause 8(4) (i) of the per NCTE Regulations, 2014.

Notarized copies of Building Plan and Building Completion Certificate have also not been submitted. FDRs not submitted.

**Hence, Show Cause Notice be issued on the above grounds."**

AND WHEREAS, the Show Cause Notice was issued to the institution on **14.03.2016** and the reply of Show Cause Notice was received on **11.04.2016**.

AND WHEREAS, the reply was placed before WRC in its **256<sup>th</sup> Meeting held on July 19-21, 2016** and the Committee decided that "...Show Cause Notice dt. 14/03/2016 was issued, to which the applicant has submitted a reply received on 11/04/2016. The applicant has contested that NOC of the affiliating body is not necessary.

As regards the name of an individual on the Registry of the land, the applicant has claimed that all the documents are in the name of the Society. The land documents were seen again by the WRC. The Registry shows that the land is in the name of one Smt. Santosh Gupta.

Hence, until this document is amended and the land is registered and in the name of Times Computer Education Society, the contravention of Clause 8(4) (i) of the NCTE Regulation, 2014 will continue.

**Hence, Clarification be obtained on this ground."**

AND WHEREAS, the Clarification letter was issued to the institution on **26.07.2016** and the reply of clarification letter was received on **12.08.2016**.

AND WHEREAS, the reply was placed before WRC in its **263<sup>rd</sup> Meeting held on November 25-27, 2016** and the Committee decided that "...In response to the clarification letter, issued on 26/07/2016, the institution replied that they have submitted the land document to the Sub-Registrar for amendment which is awaited. The document should be submitted within 30 days.

The case be put up as soon as this document is received."

AND WHEREAS, the information letter was issued to the institution on **29.11.2016** and the reply of letter was received on **02.01.2017**.

**AND WHEREAS**, the reply was placed before WRC in its 272<sup>nd</sup> Meeting held on April 6-8, 2017 and the Committee decided that "...In the 263<sup>rd</sup> meeting, the WRC had given 30 days for the corrected document to be submitted.

**Since, the Society has not submitted the required document till date, Recognition is refused."**

**NOW, THEREFORE**, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **TIMES COLLEGE, KHASRA NO- 102, 111, PLOT NO- 19, VILLAGE- GWARI, POST OFFICE- DAMOH, TEHSIL- DAMOH, CITY- DAMOH, DISTRICT: DAMOH- 470661, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website [www.ncte-india.org](http://www.ncte-india.org).
