REFUSAL ORDER

WHEREAS, in terms of Section 15 (1) of the NCTE Act, 1993, **Shri RSM Shiksha Samiti Nowgong, Plot no.: 906/2/2, Street/Road: Chhatarpur Road Nowgong, Vill.: Naygong, P.O.: Naygong, Teh./Tal.: Naygong, Town/City: Naygong, Dist.: Chhatarpur - 471201, Madhya Pradesh (WRCAPP3467/B.A.B.Ed.)** had submitted the application on **30.06.2015** to the Western Regional Committee of the NCTE for grant of recognition/permission to **Shri RSM College of Education, Plot no.: 906/2/2, Street/Road: NH75, Vill.:Naygong, P.O.:Naygong, Teh./Tal.: Naygong, Town/City: Naygong, Dist.:Chhatarpur - 471201, Madhya Pradesh** for **B.A.B.Ed. 4 years integrated course**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 01.08.2015 requesting to give their recommendation/ comments.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, in its 241st meeting of the WRC held on February 4-6, 2016, was decided that WRO should process the case and constitute VT/issue Show Cause Notice, as the case may be.

AND WHEREAS, application was scrutinized and following deficiencies/shortcomings were observed:-

1. Notarized copy of Society registration certificate submitted. Memorandum, By-laws of the society / trust are not submitted.
2. Originally certified copy of registered land documents not submitted.
3. Originally notarized copy of Change of Land Use certificate issued by Sub-Divisional Officer, Nowgong not submitted. Diverted area is less as per norms.
4. Notarized copy of Building plan approved by competent authority not submitted.
5. Notarized copy of Building Completion certificate issued by Govt. Engineer (RES) not submitted.
6. Originally notarized copy of Non-Encumbrance certificate issued by Sub-Registrarr/ Revenue authority not submitted.
7. FDRs of Rs. Five lakhs as Endowment fund & Rs. Seven lakhs as Reserve fund not submitted.
8. The Institution is also directed to clarify for which course it has applied, i.e. for B.A.B.Ed or B.Sc.B.Ed.

AND WHEREAS, the Show Cause Notice was issued on 20.02.2016. Reply received on 21.03.2016.

AND WHEREAS, the reply dt. 21.03.2016 of the Institution was placed before WRC in its 253rd meeting held on May 24-26, 2016. The Committee decided that "*....Show Cause Notice was issued on 20/02/2016 and reply was received on 21/03/2016. An examination of the file shows that the existing D.El.Ed. course (APP932) is running in Shri RSM College of Education,*

Khasra No. 2218/3 in Patwari Halka No. 26, whereas the new application for B.A.B.Ed. course (3467) is at Khasra No. 906/2/2 in Patwari Halka no. 37. Therefore, both the institutions are at different places and both are stand alone institutions.

Thus, this case is of a stand alone institution and cannot be processed further.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, the Clarification letter was issued on 30.05.2016.

AND WHEREAS, the reply dt. 21.06.2016 of the Institution was placed before WRC in its 263rd meeting held on November 25-27, 2016. The Committee decided that "...Clarification letter was issued on 30/05/2016 and reply was received on 21/06/2016.

In reply to the clarification letter, the management has stated that Khasra Nos. 2218/3 in PH No. 26 and Khasra No. 906/2/2 in PH No. 37 are contiguous.

In confirmation of the above, the Society should submit the Patwari Map showing that Halka Nos. 37 and 26 are contiguous. This should be supported by a certification by the Tehsildar/SDO. **Compliance in the above matters should be submitted within 30 days."**

AND WHEREAS, the Compliance letter was issued on 06.12.2016.

AND WHEREAS, the matter of reply not received was placed before WRC in its 278th meeting held on July 25-26, 2017. The Committee decided that "...Compliance letter was issued on 06.12.2016 regarding submission of Patwari Map showing the contiguity of halka no. 37 & 26. The institute has not replied till date. **Hence, Recognition is refused.** FDRs, if any, be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 15 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition/permission to **Shri RSM College of Education, Plot no.: 906/2/2, Street/Road: NH75, Vill.:Naygong, P.O.:Naygong, Teh./Tal.: Naygong, Town/City: Naygong, Dist.:Chhatarpur - 471201, Madhya Pradesh** for the **B.A.B.Ed. 4 - Years** intregated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
