**Refusal Order**

Whereas in terms of section 15 of the NCTE Act, 1993, Manglam Education Society, Street/Road – Jain Lace House Mishra Complex, Village – Malviya Road, District – Raipur, Chhattisgarh-492001 had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Konark College of Education, Plot/Khasra No. – 2946/1, Street No. Khokhsha, Village – Khokhsha, District – Janjgir Champa, Chhattisgarh - 495668 for conducting M.Ed. (Addl.) course.

And whereas, the proposal was examined by WRC in its 241<sup>st</sup> meeting held on 4<sup>th</sup>-6<sup>th</sup> February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply of Show Cause Notice was not submitted by the institution.

And whereas, the matter was placed before the WRC in its 271<sup>st</sup> meeting held on 23<sup>rd</sup>-25<sup>th</sup> March, 2017 and Committee decided to issue refusal order to the institution on the following points:-

*"The case file was seen. Show Cause Notice was issued to the institution 13.02.2016 regarding CLU, building plan, building completion certificate and FDRs. Reply has not been received till date.*

*Hence, Recognition is refused u/s 15(3)(b) of NCTE Act, 1993. FDRs be returned, if any."*

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to B.Ed. course to Konark College of Education, Plot/Khasra No. – 2946/1, Street No. Khokhsha, Village – Khokhsha, District – Janjgir Champa, Chhattisgarh - 495668.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
