## Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, The Radiant Way College, Plot No. - 497, 498, Street No. - Pt. R.S.U., Village - Dumar Talab, Post Office - R.S.U., Tehsil/Taluka - Raipur, District - Raipur, Chhattisgarh - 492010, had submitted the application on 30.06.2015 in the Western Regional Committee, NCTE, Bhopal under section 14 of the NCTE Act, 1993, for grant of recognition for conducting D.El.Ed. Course.

And whereas, the proposal was examined and the Show Cause Notice letter was issued to the institution on 11.02.2016, and reply not submitted by the institution.

And whereas, the matter was placed in 266<sup>th</sup> meeting held on 10<sup>th</sup> - 12<sup>th</sup> January, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Clarification letter/Show Cause Notice dt. 11/02/2016 was issued to the institution. Reply has not been received till date.

**Hence, Recognition is refused."**

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to The Radiant Way College, Plot No. - 497, 498, Street No. - Pt. R.S.U., Village - Dumar Talab, Post Office - R.S.U., Tehsil/Taluka - Raipur, District - Raipur, Chhattisgarh - 492010.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
