REFUSAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, VICTORIA COLLEGE OF EDUCATION, PLOT NO- 255/1/1/1, STREET NO- KHANDWA ROAD, VILLAGE- GRAM MOROD, POST OFFICE- TEJAJI NAGAR, TEHSIL- INDORE, CITY- INDORE, DISTRICT: INDORE- 452021, MADHYA PRADESH had submitted the application on 13.07.2015 to the Western Regional Committee of the NCTE for grant of recognition for B.Ed. Course of 2 years duration.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has recommended the case.

AND WHEREAS, the matter was placed before the WRC in its 243rd Meeting held on February 18-20, 2016, and the Committee observed that "...The applicant has applied online on 13/07/2015 which is after the last date i.e. 30/06/2015 for online applications.

Hence, the application is summarily rejected.

FDRs be returned, if submitted."

AND WHEREAS, the Rejection letter was issued on 23.02.2016.

AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Rejection letter dated 23.02.2016 and the Council vide order dated 02.09.2016 remanding the case to WRC.

AND WHEREAS, an appeal order was placed before the WRC in its 261st Meeting held on October 26-28, 2016 and the Committee observed that "...This is a case of Appeal. The Appellate Authority vide letter dt. 02/09/2016 has remanded the case to WRC for further processing.

The RD WRO should get this case processed and should put them in the next meeting."

AND WHEREAS, the matter was placed before the WRC in its 264th Meeting held on December 14-15, 2016 and the Committee observed that "...Consequent to the appeal order dt. 20/09/2016, the documents were examined and it was found that they are in order except for non-submission of Building Completion Certificate.

Hence, VT be constituted. The VT should obtain from the management a valid Building Completion Certificate."

AND WHEREAS, the inspection letter issued to the institution through online on 21.12.2016 & 25.01.2017 and the inspection conducted of the institution on 26.01.2017 and VTR received in office on 30.01.2017.

AND WHEREAS, the Visiting Report was placed before the WRC in its 268th Meeting held on February 09-11, 2017 and the Committee observed that "...The institution is already running 2 units of the B.Ed. course and has now applied for 2 additional units of the B.Ed. course.

However, the NCTE Hqrs. vide letter dated 08.12.2016 has clarified that, "...the institutions may apply for increase in intake in the same course already recognized provided it does not exceed maximum of two permissible units in case of DPSE, D.El.Ed. and B.Ed. Any application for increase in intake beyond two permissible units in these three courses is not permissible under the regulation..."

Hence, Show Cause Notice be issued on the above ground.

Reply should be submitted within 30 days."

AND WHEREAS, the Show Cause Notice was issued to the institution on 17.02.2017 and the reply received on 21.03.2017.

AND WHEREAS, the matter was placed before the WRC in its 273rd Meeting held on April 18-19, 2017, and the Committee observed that "...Show Cause Notice was issued on 17/02/2017 on the ground that it cannot have more than 2 units of the B.Ed. course as per the NCTE Hqrs. letter dt. 08/12/2016.

The institution has not given any valid reply. When the application is under process, orders from competent authorities have to be adhered to, as and when they are received.

Hence, Recognition is refused. FDRs, if any be returned."

NOW, THEREFORE, the WRC, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, hereby refuses recognition to **VICTORIA COLLEGE OF EDUCATION, PLOT NO- 255/1/1/1, STREET NO- KHANDWA ROAD, VILLAGE- GRAM MOROD, POST OFFICE- TEJAJI NAGAR, TEHSIL- INDORE, CITY- INDORE, DISTRICT: INDORE- 452021, MADHYA PRADESH** for **B.ED.** Course.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Ba.hadurshah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online Mode using website www.ncte-india.org.
