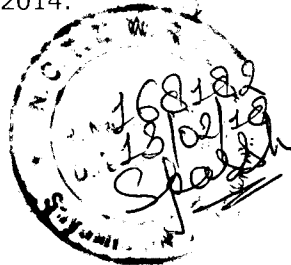
Sir/Madam,

I am to inform you that the case of your institution for B.A.B.Ed./B.Sc.B.Ed. 4 years integrated course was placed before WRC in its 286<sup>th</sup> meeting held on January 16-17, 2018 and the Committee observed that:-

"...The Appellate Authority vide order dated 21.08.2017 had kept the decisions of the WRC pending till the cases regarding D.El.Ed. and B.Ed. courses are decided.

The institution was provided two months to submit the minority certificate with regard to D.El.Ed. and B.Ed. courses, which was again further extended upto 21.10.2017. Since the institution failed to provide the required certificate, Recognition for the two courses were refused vide decisions taken in the 284<sup>th</sup> meeting. **Hence, Recognition for B.A.B.Ed./B.Sc.B.Ed. cannot be considered as the college becomes a standalone institution, which is not permitted under clause 2(b) and 3(a) of the NCTE Regulations, 2014.**"
