I am to inform you that the case of your institution for **B.Ed.** course was placed before WRC in its 256th Meeting held on July 19-21, 2016 and the Committee observed that:

"Show Cause Notice dt. 16/028/20016 was issued to the Society. In the reply dt. 15/03/2016, the clerical errors in the online form and in the Land Registration have been explained. As regards the built up area, an examination of the Building Completion Certificate shows that the built up area is shown 13892 sq. ft. /1290.60 sq. mtrs. which is less as per the Norms. However, in the Building Plan, the proposed built up area is shown 3506 sq. mtrs.

Hence, Clarification be obtained on this ground."

In view of the above, you are requested to clarify with supporting document within ¹⁵ days from the date of issue of this letter.

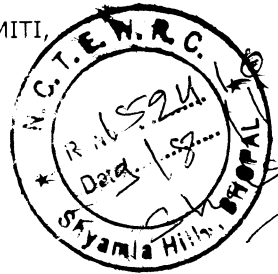
