WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to **JAI MAHAKALI SHIKSHAN SANSTHAS RANIBAI AGNIHOTRI SHARIRIK SHIKSHAN MAHAVIDYALAYA RAMNAGAR WARDHA CITY: WARDHA (B.P.Ed.)**, for conducting B.P.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/2K/10561-567 dt. 07.12.2000.

And whereas, a revised recognition order no. WRC/APW0242/114079/2015/147389-396 dt.31.05.2015 was issued to the institution for conducting B.P.Ed. Course of two years duration with an annual intake of 100 students.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 27.10.2016.

And whereas, reply of show cause notice was not submitted by the institution and the matter was placed before the WRC in its 280th meeting held on August 31th - Sep-01st, 2017 and committee decided as follows :-

"The case file was seen. Show Cause Notice was issued to the institution on 27.10.2016. The institute has not replied till date.

Hence, Recognition is withdrawn from the session 2018-2019.
FDRs, if any, are returned."

Now, therefore, the recognition of Jai Mahakali Shikshan Sansthas Ranibai Agnihotri Sharirik Shikshn Mahavidyalaya Ramnagar Wardha City: Wardha (B.P.Ed.) for (100 students) of the B.P.ED course is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
