WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to DNYANDEEP SHIKSHAN PRASARAK MANDALS BABASAHEB PARANJAPE COLLEGE OF PHYSICAL LOKHANDI SAWARGAON ROAD POST CHANAI TAH-AMBAJOGAI CITY:BEED, MAHARASHTRA for conducting B.P.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/16/99/4886-4889 dt. 12.08.1999.

And whereas, a revised recognition order no. WRC/APW0872/114125/2015/148248, 8249, 8253, 8257, 8258, 8259, 8260, 8261 dt. 31.05.2015 was issued to the institution for conducting B.P.Ed. Course of two years duration with an annual intake of 100 students.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 09.08.2016.

And whereas, reply of show cause notice was not submitted by the institution and the matter was placed before the WRC in its 280<sup>th</sup> meeting held on August 31<sup>th</sup> - Sep-01<sup>st</sup>, 2017 and committee decided as follows :-

*"The case file was seen. Show Cause Notice was issued to the institution on 09.08.2016. The institute has not replied till date.*

**Hence, Recognition is withdrawn from the session 2018-2019.**  
*FDRs, if any, are returned."*

Now, therefore, the recognition of Dnyandeep Shikshan Prasarak Mandals Babasaheb Paranjape College Of Physical Lokhandi Sawargaon Road Post Chanai Tah-Ambajogai City:Beed, Maharashtra for (100 students) of the B.P.ED course is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17 (1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
