ORDER

Whereas, recognition was granted to the institution, **Br. Nath Pai College, At. Post. Kundal, Tal.-Kundal Sindhudurg, Maharashtra** for **B.Ed & D.Ed** course with an annual intake of 100 & 50 students vide order no. F.No.WRC/2-32/123162/76/2005 dated 09.08.2005 & D.Ed Course vide order no. WRC/5-6/98/2007/C-18280-18285 dt. 27.06.2017 respectively.

And whereas, the Institution vide letter dt. 04.03.2013 submitted an application for **shifting of premises** from Br. Nath Pai College, Plot No. 13/1 & P-57, Sulbha Building MIDC Road At Post-Kundal, Tal-Kundal Sindhudurg, Maharashtra-416520 to **Br. Nath Pai Shaikshanik Bhavan, MIDC Plot No. 04, (Maharashtra Industrial Development Corporation Area Kundal), Sindhudurg, Maharashtra-416520.**

And whereas, the matter was placed before WRC in its 231st meeting held on August 25-26, 2015, The Committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 05.09.2015 and the institution submitted reply of SCN on 07.12.2015.

And whereas, the matter was placed before WRC in its 252nd meeting held on May 09-10, 2016, The Committee decided to issue clarification to the institution. Accordingly, clarification was issued on 20.05.2016 and the institution submitted reply of clarification on 10.08.2016

And whereas, the matter was placed before the WRC in its 277th meeting held on April 29-30, 2017. The Committee decided as under:-.

"...Clarification letter was issued on 20.05.2016 regarding insufficiency of land built up area. The institution has not provided any valid reply to the points of the clarification letter.

Hence Shifting is not permitted and Recognition is withdrawn."

Now, therefore, the permission for change of premises is not permitted from. Nath Pai College, Plot No. 13/1 & P-57, Sulbha Building MIDC Road At Post-Kundal, Tal-Kundal Sindhudurg, Maharashtra-416520 to Br. Nath Pai Shaikshanik Bhavan, MIDC Plot No. 04, (Maharashtra Industrial Development Corporation Area Kundal), Sindhudurg, Maharashtra-416520" for conducting the D.Ed. (M) (Co.Ed.) course with immediate effect.
