ORDER

WHEREAS, WRC, NCTE had granted recognition/permission, Vetalwadis Shikshan Shastra Mahavidyalaya, Shri Tulja Bhavani Bahuuddeshiy Samaj Sevi Sanstha, At. Vetalwadi, Tq Madha, Solapur-413209, Maharashtra vide order dated 22.07.2005 to start the B.ED. (CO-ED) course with an annual intake of 100 students

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 12.03.2015. The institution submitted affidavit vide letter dated 01.07.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

The institution vide its letter No. 2015-16/62 dated 01.02.2016 has requested this office to reduce the intake of 2 units (100 students) to 1 unit (50 students).

AND WHEREAS, the matter regarding reduce in intake was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "...Institutions which have requested for reducing intake may be permitted."

Now, therefore, the intake of the institution is here by reduce from 2 units (100 students) to 1 units (50 students) to conduct of B.Ed. course.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
