**WHEREAS**, WRC, NCTE had granted recognition/permission **Sarvodaya Mahila Mandal Kamla Devi Shikshan Mahavidyalaya, Polytechnic Chandrapur Balaji Ward, Dist-Chandrapur, Maharashtra** vide order dated **29.01.2014** to start the **B.ED. (CO-ED)** course with an annual intake of **100** students

**AND WHEREAS**, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 21.01.2015. The institution submitted affidavit vide letter dated **08.01.2015**.

**AND WHEREAS**, Revised Recognition order was issued for two basic units (each 50 students) to the institution on **31.05.2015**.

**AND WHEREAS**, the institution vide letter dated 16.04.2016 has requested to reduce intake of 100(two-units)students to 50 students (one - units)

**AND WHEREAS**, the matter was placed in **259<sup>th</sup> Meeting of WRC held on September 21-23, 2016** and the Committee decided that "...Institutions which have requested for reducing intake may be permitted."

**Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)**

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
