WHEREAS, WRC, NCTE had granted recognition/permission to B.ED.WOMENS COLLEGE, SOMNATHARPAN SHIKSHAN PRASARAK SANSTHA, PLOT NO.746/1 & PLOT NO.9 & 10, KHASRA NO. 11443/314, SAVDA ROAD, RAVER, DIST-JALGAON, MAHARASHTRA vide order dated 22-11-2008 to start the B.ED. (CO-ED) course with an annual intake of 100 students

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 20-05-2015. The institution submitted affidavit vide letter dated 09.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND WHEREAS, the institution vide letter dated 20.05.2016 has requested to reduce intake of 100(two-units)students to 50 students (one - units)

AND WHEREAS, the matter was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "...Institutions which have requested for reducing intake may be permitted."

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.
