### ORDER

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 22.03.2017.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 272<sup>nd</sup> Meeting held on April 6-8, 2017. The Committee decided that "...This is a case for shifting. The VT visited the institution on 22/03/2017. The CD was seen and VTR perused. The CD shows a building with adequate instructional and infrastructural facilities. The VT has recommended the case. **Hence, Shifting is permitted.**"
