**ORDER**

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to ROYAL COLLEGE OF TEACHER EDUCATION, SAVOY PALACE, MHOW ROAD, RATLAM, MADHYA PRADESH for D.El.Ed. course vide order dated 24.12.2006 for an annual intake of 50 students.

AND WHEREAS, the institution applied for change of name of D.El.Ed course from ROYAL COLLEGE OF TEACHER EDUCATION to ROYAL INSTITUTE OF MANAGEMENT AND ADVANCED STUDIES.

AND WHEREAS, the matter was placed before WRC in its 282<sup>nd</sup> Meeting held on October 24-26, 2017 and the Committee decided that "...ROYAL COLLEGE OF TEACHER EDUCATION had applied for change of name from 'ROYAL COLLEGE OF TEACHER EDUCATION' to 'ROYAL INSTITUTE OF MANAGEMENT AND ADVANCED STUDIES'. It has also paid the necessary fee of Rs.1.50 lakhs. **Hence, change of name is permitted and should be incorporated in all files.**"

NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, permission is hereby granted for change of name from ROYAL COLLEGE OF TEACHER EDUCATION to **ROYAL INSTITUTE OF MANAGEMENT AND ADVANCED STUDIES** with immediate effect for conducting D.EL.ED. course with an annual intake of 50 students.
