WITHDRAWAL ORDER

WHEREAS, recognition was granted to RISHIKUL GROUP OF D.ED. COLLEGE, A - 94, 95, GOVINDPURI, UNIVERSITY ROAD, GWALIOR, MADHYA PRADESH under section 15 of NCTE Act, 1993 for conducting D.Ed. course vide order dated 16.11.2004 for an annual intake of 50 seats.

AND WHEREAS, the Inspection of the institution was conducted by NCTE Hqrs u/s 13 on 24.05.2012 and deficiency letter was issued to the institution on 01.08.2012.

AND WHEREAS, the reply submitted by the institution on 06.09.2012 was placed before WRC in its 177th meeting held from January 7-8, 2013 and the Committee decided that clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 06.02.2013.

AND WHEREAS, the institution had not submitted any reply/representation. The matter was placed before WRC in its 185th meeting held from June 13-15, 2013 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued to the institution on 01.07.2013.

AND WHEREAS, the institution again had not submitted any reply/representation. The matter was placed before WRC in its 192nd meeting held from October 30-31, 2013 and the Committee observed that "...On the basis of the decision of the WRC taken in the 185th meeting, Show Cause Notice dated 01.07.2013 was issued to the institution to which the institution has not replied. Earlier to that a letter to obtain clarification on the same issues dated 06.02.2013 had been issued. Since the institution has not given any response to the letter for obtaining clarification and the Show Cause Notice, Recognition is withdrawn from the end of the academic session next to the date of issue of withdrawal order." Accordingly, Withdrawal order issued to the institution on 20.11.2013.

AND WHEREAS, the institution thereafter preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Withdrawal order dated 20.11.2013 and the Council vide order dated 19.02.2015 concluded that the appeal to the extent that the withdrawal order has been issued without following the procedure laid down, deserved to be accepted and the order of the WRC set aside.

AND WHEREAS, the aforesaid appeal order was placed before WRC in its 224th meeting held on April 29-30, 2015 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 21.05.2015.

AND WHEREAS, no reply was received from the institution. The matter was placed before WRC in its 236th meeting held on December 15-16, 2015 and the Committee decided that "...The Show Cause Notice dated 21.05.2015 was issued to the institution u/s 17 stating that it should comply with the formalities necessary for shifting of premises, otherwise Recognition was liable to be withdrawn. This Show Cause Notice was issued at the address, 'A-94, 95, GOVINDPURI, UNIVERSITY ROAD, GWALIOR'. This address tallies with the address in its letter dated 17.06.2015 in which it has requested for uploading the name of the institution on the website. It is clear that the institution has received a Show Cause Notice dated 21.05.2015, but has not cared to reply, and to comply with the provisions of 8(9) of NCTE Regulations, 2014, inspite of notice. **Hence, Recognition is withdrawn from the end of the academic session next to the date of issue of withdrawal order.**"

NOW THEREFORE, the recognition granted to RISHIKUL GROUP OF D.ED. COLLEGE, A - 94, 95, GOVINDPURI, UNIVERSITY ROAD, GWALIOR, MADHYA PRADESH for conducting D.Ed. course vide order dated 16.11.2004 is hereby withdrawn under section 17(1) of the NCTE Act, 1993, from the end of the academic session next to the date of issue of withdrawal order.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
