**ORDER
(NAME CHANGE)**

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to **ROYAL COLLEGE OF TEACHER EDUCATION, SAVOY PALACE, MHOW ROAD, DISTRICT.- RATLAM, - 457001, MADHYA PRADESH** for B.Ed. (Co-Ed) course vide order dated **22.11.2004** for an annual intake of 100 seats.

AND WHEREAS, WRC issued Revised Recognition Order to **ROYAL COLLEGE OF TEACHER EDUCATION, SAVOY PALACE, MHOW ROAD, DISTRICT.- RATLAM, - 457001, MADHYA PRADESH** vide order dated **31.05.2015** for conducting B.Ed. (Co.Ed) course of two year duration with an annual intake of 100 students (Two basic units of 50 students each) from the academic session 2015-2016.
